	A written report by staff of the December 9, 2011 Condominium Consultant Forum/Workshop was distributed for informational purposes. It was noted that all consultants were in attendance along with the CRC Vice Chair, DCCA Deputy Director and PVLD Licensing Administrator.
	The workshop provided for continuity between the condominium consultants, discussion of concerns, consultant review of issues and resolutions, related court cases, review of new legislation, forms, and recent committee decisions. It was recommended to revise where needed the project registration instructions and forms.
	SEO Fujitani noted that the DCCA Administration was in favor of the condominium consultant's forum be held via video conferencing rather than flying in the neighbor island consultants to attend and participate in the forum. The condominium consultants, when polled, expressed the extreme difficulty when not having a face to face interaction in discussing the complex issues which arise.
