Consultants – Contracts – Staff Delegation-Commission Approval of Consultants' Additional Compensation for Subsequent Review of Developers' Additional/Supplemental Documents/Information To Complete Project Registration Application And Any Developer's Rewrites Of The Developer's Public Report

Specialist Yee recalled for the committee that the current condo consultant's contract provides for additional compensation for the consultant review of any supplemental documents and/or information that a consultant deems necessary to complete the consultant's review.

Specialist Yee then reported that staff is requesting that the Commission consider a delegation to staff to approve a consultant's recommended additional compensation amounts to be charged for subsequent reviews as long as the following conditions are met:

- The consultant completes and submits to Commission staff the "Professional Services Contract – Condominium Consultant Subsequent Review – Request for Additional Fees" form (developed by staff) that includes the following:
 - a description of the scope of the subsequent review;
 - estimated hours (multiplied by \$150); and
 - additional expenses if any.
- The developer declares that the additional charges is for consultant's review service of additional and or supplemental documents and or information that the consultant deems necessary to complete any one or more of the following:
 - the consultant's review of the information and disclosures included in or omitted from the developer's proposed public report;
 - the project registration application;
 - the consultant's review, of complex amendments(changes) to the developer's public report and or project registration application involving more than two (2) material changes; and
 - the consultant's review of any subsequent developer's rewrites of the developer's proposed public report incorporating or omitting any disclosures and or information based on any additional and or supplemental documents and or information subsequently submitted by the developer;
- 3. The requested additional compensation does not exceed \$1200 and is for an hourly rate of \$150.00 per hour.

Commissioner Senter questioned the definition of a complex revision and that the term is not clear. Specialist Yee responded then in those situations the issue will come to the Commission for their review and suggested the inclusion of a definition in proposed rules currently being drafted.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Faulkner, it was voted on and unanimously carried to approve the delegation to staff a consultants' additional compensation for subsequent review of developers' additional/supplemental documents/information to complete project registration application and any developer's rewrites of the developer's public report.

Staff shall approve a consultant's request for additional compensation only for those requests satisfying the three conditions as presented and described by staff.
