Mr. Prothero was present.

Mr. Prothero stated that he researched the continuing education courses being offered and looked for gaps in areas that he felt were not being covered by courses offered, and found that there were no courses on negotiating. He decided to develop this course.

Mr. Prothero was asked about his awards received from Century 21. He stated that they are awards based on production, either gross commissions or gross units, and they are national awards. He stated that he does not recall how many sales he has made; however, he noted that he has been in real estate for the past six to seven years with three years as a broker. He stated that he is not in a supervisory position and is not a broker-in-charge.

The Chair commended Mr. Prothero for wanting to develop more continuing education courses.

The Commissioners agreed that the course materials do not reflect the title of the course, as the course addresses how to write a good Purchase Contract, and does not focus on negotiation skills. It was suggested that Mr. Prothero consider changing the title of the course to more accurately reflect the course content, or amending the course to include substantive material on actual negotiating skills.

Commissioner Abrams moved to defer decision making on this application. Commissioner Kuriyama seconded the motion. The motion was voted on and unanimously carried.
