Call to Order: The Vice Chair called the meeting to order at 10:12 a.m., at which time quorum

was established.

Chair's Report:

The Vice Chair stated the Committee may move into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Commissioners Apisa, Ball and Suiso were excused from the meeting. Prior notification of their non-attendance was received.

Real Estate Specialist's Report: Minutes of Previous Meeting

Upon a motion by Commissioner Gendrano, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to accept the minutes of the December 8, 2010, Education Review Committee meeting.

Continuing Education:

Continuing Education Core Course

Request for Quotations released 12/14/10 - 2011-2012 Core Course

Senior Specialist Fujimura reported that the Request for Quotations for the development of the 2011-2012 Core Course was released via the HePS on December 14, 2010, with a closing date of December 29, 2010, 4:30 p.m. She reported that quotes were received from Digital Learning Centers, LLC and Pacific Real Estate Institute.

Digital Learning Centers, LLC

David Catanzaro and Jean Catanzaro were present.

Mr. Catanzaro stated that Digital Learning Centers, LLC ("Digital") develops software and online education materials. Mr. Catanzaro stated that Digital has submitted bids in three consecutive bienniums.

Mr. Catanzaro stated that if awarded the job, Digital will do a good job and intends to make the system better.

Mr. Catanzaro provided the Committee with Digital's staff qualifications and background. He stated that Jean Catanzaro has experience writing courses and is in charge of compliance for Digital. Monika Catanzaro is a licensed attorney and is Digital's in-house counsel and contributes to course development. Christopher Catanzaro is responsible for content technology and programming of their online courses.

Mr. Catanzaro reported that last biennium, Digital provided 10,000 courses to Hawaii licensees and some on the mainland. He stated that it is a great base to survey the Hawaii licensees. He added that 99.7% of their students found the information in their courses were clearly explained and 99.59% of their students would recommend their courses to others. Mr. Catanzaro provided the Committee with a summary of thank you letters from previous students.

Ms. Jean Catanzaro stated that if awarded the job, Digital will match the course content and delivery mechanism, make the course content easy to use and easy to understand. She added that Digital is looking forward to the opportunity and to meeting the needs of the Commission and licensees.

In closing, Mr. Catanzaro stated that Digital has written most of their courses, is a member of ARELLO and IDECC certified.

Pacific Real Estate Institute

Mr. Kenneth Chong was present.

Mr. Chong stated that Pacific Real Estate Institute ("PREI") is pleased to submit a proposal. He stated with their partner, ProSchools, they will produce a quality, informative and engaging core course in a cost effective and timely manner.

Mr. Chong stated ProSchools is ARELLO certified, provides prelicense and continuing education courses across the country and has been around since 1950. ProSchools has a national reputation for excellence of work.

Mr. Chong stated that their objective will be to beef up the online section of the core course. There is always room for improvement and they will aim in that direction.

Mr. Chong stated that ProSchools is able to obtain nationwide information and will be able to disperse that information locally.

In closing, Mr. Chong stated that he is involved in legislative activities and has also worked with the Regulated Industries Complaints Office as an advisory committee member, which gives him a good perspective on areas where licensees are running afoul.

Upon a motion by Commissioner Nishihara, seconded by Commissioner Gendrano, it was voted on and unanimously carried to take this matter under advisement.

2011-2012 Continuing Education Providers and Courses Ratification List

Upon a motion by Commissioner Gendrano, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to ratify the attached list.

Course – "Accredited Buyer Representative Designation Program"; Author/Owner: Accredited Buyer's Representative Designation Course (ABR®); Provider: Hogan School of Real Estate: Clock Hours: 12 (Previously certified for 6 hours. Deferred from 12/8/10 ERC mtg.)

Senior Specialist Fujimura reported that this application was deferred from the December 8, 2010, meeting as the Committee had concerns about the course content. She reported that the applicant has reconfigured the content and has certified that the course meets the definition of continuing education.

The Commissioners noted that chapter 7, "Follow Through," and chapter 8, "Marketing Fundamentals," do not meet the definition of continuing education as stated in Hawaii Administrative Rules section 16-99-100.

Senior Specialist Fujimura stated that breaks and exam time are excluded and the course was previously certified for six hours.

Commissioner Gendrano moved to approve "Accredited Buyer Representative Designation Program" as a ten (10) credit hour continuing education elective course. Commissioner Kuriyama seconded the motion. The motion was voted on and unanimously carried.

Course – "NAR's Green Designation Core Course"; Author/Owner: Real Estate Buyer's Agent Council (REBAC); Provider: Hogan School of Real Estate; Clock Hours: 12 (Previously certified for 6 hours. Deferred from 12/8/10 ERC mtg.)

The Commissioners noted that section IV, "Green Buyers and Sellers," and section V, "Greening Your Real Estate Practice," do not meet the definition of continuing education as stated in Hawaii Administrative Rules section 16-99-100.

Commissioner Nishihara moved to approve "NAR's Green Designation Core Course" as a nine (9) credit hour continuing education elective course. Commissioner Kuriyama seconded the motion. The motion was voted on and unanimously carried.

Course – "CI Intro: Introduction to Commercial Investment Real Estate Analysis"; Author/Owner: CCIM Institute; Provider: Hawaii CCIM Chapter; Clock Hours: 12 (previously approved for 6 hours)

Upon a motion by Commissioner Nishihara, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "CI Intro: Introduction to Commercial Investment Real Estate Analysis" as a 12 credit hour continuing education elective course.

Course – "CI 101: Financial Analysis for Commercial Investment Real Estate"; Author/Owner: CCIM Institute; Provider: Hawaii CCIM Chapter; Clock Hours: 12 (previously approved for 6 hours)

Upon a motion by Commissioner Harvey, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "CI 101: Financial Analysis for Commercial Investment Real Estate" as a 12 credit hour continuing education elective course.

Course – "CI 102: Market Analysis for Commercial Investment Real Estate"; Author/Owner: CCIM Institute; Provider: Hawaii CCIM Chapter; Clock Hours: 12 (previously approved for 6 hours)

Upon a motion by Commissioner Harvey, seconded by Commissioner Kuriyama, it was voted on and unanimously carried to approve "CI 102: Market Analysis for Commercial Investment Real Estate" as 12 credit hour continuing education elective course.

Course – "CI 103: User Decision Analysis for Commercial Investment Real Estate"; Author/Owner: CCIM Institute; Provider: Hawaii CCIM Chapter; Clock Hours: 12 (previously approved for 6 hours)

Upon a motion by Commissioner Harvey, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "CI 103: User Decision Analysis for Commercial Investment Real Estate" as a 12 credit hour continuing education elective course.

Course – "CI 104: Investment Analysis for Commercial Investment Real Estate"; Author/Owner: CCIM Institute; Provider: Hawaii CCIM Chapter; Clock Hours: 12 (previously approved for 6 hours)

Upon a motion by Commissioner Harvey, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "CI 104: Investment Analysis for Commercial Investment Real Estate" as a 12 credit hour continuing education elective course.

Provider – 360training.com, Inc., Administrator – Angela Shipe

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve 360training.com, Inc. as a continuing education provider.

Course – "Property Management – Taking Care of Business"; Author/Owner: 360training.com, Inc.; Provider: 360training.com, Inc. (pending approval); Clock Hours: 8

Commissioner Loudermilk moved to approve "Property Management – Taking Care of Business" as a seven (7) credit hour continuing education elective course. Commissioner Harvey seconded the motion.

Commissioner Nishihara questioned if the course was compliant with Hawaii laws and rules. She added that clarification on law references should be provided and needs more defining.

Commissioner Loudermilk withdrew her motion. Commissioner Harvey withdrew his second.

Commissioner Nishihara moved to defer decision making on this application in order for the applicant to provide specific reference to applicable Hawaii laws and clarification of course content meeting the definition of continuing education as stated in Hawaii Administrative Rules section 16-99-100. Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "Homeowners Association Management"; Author/Owner: 360training.com, Inc.; Provider: 360training.com, Inc. (pending approval); Clock Hours: 12

The Commissioners had concerns about reference to applicable Hawaii laws regarding owner's associations.

Commissioner Gendrano moved to defer decision making on this application in order for the applicant to provide specific reference to applicable Hawaii laws regarding owner's associations, in particular Hawaii condominium laws in Hawaii Revised Statutes chapter 514B. Commissioner Kuriyama seconded the motion. The motion was voted on and unanimously carried.

Course – "Intro to Property Management"; Author/Owner: 360training.com, Inc.; Provider: 360training.com, Inc. (pending approval); Clock Hours: 15

The Commissioners had concerns that certain topics of the course may not meet the definition of continuing education and had concerns about reference to applicable Hawaii laws.

Commissioner Nishihara moved to defer decision making on this application in order for the applicant to provide specific reference to applicable Hawaii laws (e.g. Hawaii Revised Statutes chapter 515, "Discrimination in Real Property Transactions Act") and clarification of course content meeting the definition of continuing education as stated in Hawaii Administrative Rules section 16-99-100. Commissioner Gendrano seconded the motion. The motion was voted on and unanimously carried.

Course – "Risk Management in Selling a Business/Protecting Buyers/Sellers and Agents"; Author/Owner: Richard W. Daggett; Provider: Richard Daggett School of Real Estate; Course Categories: Contracts, Real Estate Law, Risk Management; Clock Hours: 3

Commissioner Nishihara was concerned that under the courses learning objectives the subtitle "Attempting to draft legal documents" should be rephrased to better reflect the main point of the topic.

Commissioner Nishihara moved to approve "Risk Management in Selling a Business/Protecting Buyers/Sellers and Agents" as a three (3) credit hour continuing education elective course, under the course categories Contracts, Real Estate Law and Risk Management, subject to amendment of the subtitle "Attempting to draft legal documents" to reflect the main point that "students should know what they can draft as licensees, and when they need the services of an attorney for drafting documents." Commissioner Gendrano seconded the motion. The motion was voted on and unanimously carried.

Course – "Introduction to Real Estate Purchases with IRAs and Qualified Plans"; Author/Owner: Dan Falardeau; Provider: Abe Lee Seminars; Course Categories: Investment, Property Ownership and Development, Other – Real Estate IRAs; Clock Hours: 3

There were concerns raised that the course content may involve securities issues.

Commissioner Nishihara moved to defer decision making on this application and requested the appearance of a representative at the next scheduled Education Review Committee meeting to discuss and clarify the course content. Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "Hawaii Land Use Laws Related to Cultural Resources"; Author/Owner: Dawn N.S. Chang; Provider: Abe lee Seminars; Course Category: Other – Hawaiian Land Rights; Clock Hours: 3

Upon a motion by Commissioner Nishihara, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "Hawaii Land Use Laws Related to Cultural Resources" as a three (3) credit hour continuing education elective course, under the course category Other – Hawaiian Land Rights.

Course – "Whole New Business"; Author/Owner: Eugene Trowbridge; Provider: Hawaii CCIM Chapter; Course Categories: Investment, Real Estate Law, Property Ownership and Development; Clock Hours: 6

The Commissioners had concerns about references to applicable Hawaii laws and were unclear about the course content and course objectives.

Commissioner Nishihara moved to defer decision making on this application and requested the appearance of a representative at the next scheduled Education Review Committee meeting to discuss the course content and course objectives. Commissioner Gendrano seconded the motion. The motion was voted on and unanimously carried.
