Call to Order: The Vice Chair called the meeting to order at 9:25 a.m., at which time guorum

was established.

Commissioners Ball, Kuriyama, Nishihara, and Suiso were excused from the meeting. Prior notification of their non-attendance was received.

Upon a motion by Commissioner Apisa, seconded by Commissioner Harvey, it was voted on and unanimously carried to accept the minutes of the April 13, 2011, Education Review Committee meeting.

Course – "Representing Buyers of Residential Real Estate;" Author/Owner: Randy L. Prothero; Provider: Russ Goode Seminars; Course Categories: Contracts, Other- Fiduciary Duties; Clock Hours: 3

Mr. Prothero was present. He stated that this course focuses on residential real estate and taking the agent from beginning to end of a transaction with the buyer. Mr. Prothero stated that the course includes group discussions and interaction within the class.

Upon a motion by Commissioner Harvey, seconded by Commissioner Apisa, it was voted on and unanimously carried to approve "Representing Buyers of Residential Real Estate" as a three credit hour continuing education elective course, under the course categories Contracts and Other – Fiduciary Duties.

Course – "Representing Sellers of Residential Real Estate;" Author/Owner: Randy L. Prothero; Provider: Russ Goode Seminars; Course Categories: Contracts, Other – Fiduciary Duties; Clock Hours: 3

Mr. Prothero stated that this is similar to the previous course, but focuses on representing the seller and takes the licensee from the beginning of the transaction, focusing on fiduciary responsibilities to clients, and to the closing of escrow.

Upon a motion by Commissioner Harvey, seconded by Commissioner Apisa, it was voted on and unanimously carried to approve "Representing Sellers of Residential Real Estate" as a three credit hour continuing education elective course, under the course category Contracts and Other – Fiduciary Duties.

Course – "Property Management of Condominium and Community Associations;" Author/Owner: Ginger Allen Kolonick; Provider: Abe Lee Seminars; Course Category: Property Management; Clock Hours: 3

Ms. Kolonick was present. Ms. Kolonick stated that she has been licensed in Hawaii for approximately 20 years and a property manager. She stated that she has taken many property management classes and found that all types of property management get lumped together. Ms. Kolonick stated that association management is totally different.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "Property Management of condominium and Community Associations" as a three credit hour continuing education elective course, under the course category Property Management.'

Course – "Real Estate Investment Analysis 2011-2012;" Author/Owner: Eddie Flores Jr. and Bryan P. Andaya; Provider: Eddie Flores Real Estate Continuing Education; Course Category: Investment; Clock Hours: 3

Mr. Andaya was present. Mr. Andaya stated that this course goes through the basic stages of real estate investing, such as due diligence, the different components of the analysis of the property, and includes student exercises and mathematical calculations.

The Commissioners raised many concerns on some of the terms and inferences made throughout the course. For example, the statement, "People invest in real estate because it is safe." This statement is not necessarily true for all situations.

There were concerns that income and returns on investments should be made clearer, as one does not want to get into the trap of projecting based on the past. The pros and cons must be clearly stated.

Mr. Andaya stated that he understands the concerns raised. He noted that the course focuses only on basic analysis but it may not be clear in the course materials.

The Commissioners also recommended that there be more caveats encouraging the consultation of the appropriate expert—possibly after each section of the course materials.

Commissioner Gendrano moved to approve "Real Estate Investment Analysis 2011-2012" as a three credit hour continuing education course, under the course category Investment, subject to recommended changes. Commissioner Harvey seconded the motion. Commissioners Harvey, Gendrano and Sherley voted aye. Commissioners Apisa and Loudermilk voted nay. The motion died.

Commissioner Apisa moved to defer decision making on this application to allow the author to clarify various topics within the course materials, Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "The Principles of Real Estate Finance and Regulation Practicum 2011;" Author/Owner/Provider: Shari S. Motooka-Higa; Course Categories: Finance, Other – Consumer Protection; Clock Hours: 3 (Deferred from February 9, 2011 ERC meeting)

Senior Specialist Fujimura reported that the materials have been reduced/paired down. She stated that Commissioner Ball previously had stylistic concerns and felt the topic was too broad. She stated that the course is more focused now.

Commissioner Gendrano moved to approve "The Principles of Real Estate Finance and Regulation Practicum 2011" as a three credit hour continuing education elective course, under the course categories Finance and Other – Consumer Protection. Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "Pension Funds and Real Estate;" Author/Owner/Provider: Abraham Lee/Abe Lee Seminars; Course Category: Investment; Clock Hours: 3

Senior Specialist Fujimura reported that this course was previously denied. The current author re-worked the topic/materials and re-submitted it as a new course application.

The Commissioners felt that this topic may be better addressed by consulting the appropriate professional, such as a tax consultant. Concerns expressed included the licensee may become involved in analyzing real property and recommending using client's pension funds for purchasing real estate. This may be too risky for a real estate licensee and beyond the licensee's area of expertise.

Commissioner Gendrano commented that the previous course seemed to be more detailed.

Commissioner Apisa moved to deny "Pension Funds and Real Estate" as a continuing education elective course based on section 16-99-101(7), Hawaii Administrative Rules. Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "CRS 205 Financing & Tax Advantages for Agents & Their Clients;" Author/Owner: Council of Residential Specialists; Provider: Hawaii Association of REALTORS[®]; Course Category: Finance; Clock Hours: 12

Commissioner Apisa stated that she is the Kauai director for CRS, but that would not affect her ability to make a decision on this matter.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "CRS 205 Financing & Tax Advantages for Agents & Their Clients" as 12 credit hour continuing education elective course, under the course category Finance.

Course – "Contracts;" Author/Owner/Provider: Hawaii Association of REALTORS[®]; Course Categories: Contracts, Risk Management; Clock Hours: 6 (Previously certified for 3 hours)

It was reported that this course is part of the GRI series.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "Contracts" as a 6 credit hour continuing education elective course, under the course categories Contracts and Risk Management.

Course – "GRI – Land Use & Development;" Author/Owner/Provider: Hawaii Association of REALTORS®; Course Category: Other – Land Use, Development, Home Inspection; Clock Hours: 6 (Previously certified for 3 hours)

Upon a motion by Commissioner Harvey, seconded by Commissioner Apisa, it was voted on and unanimously carried to approve "GRI – Land Use & Development" as a six credit hour continuing education elective course, under the course category Other – Land Use, Development, Home Inspection.

Course – "Legal, Privacy and Information Security Issues for the New Technology World of Business;" Author/Owner: Privacy Solutions Inc.; Provider: Hawaii Association of REALTORS®; Course Categories: Risk Management, Technology and the Licensee; Clock Hours: 3

Commissioner Gendrano commented that this course is new and different and there are not many courses of this type available locally.

Upon a motion by Commissioner Gendrano, seconded by Commissioner Harvey, it was voted on and unanimously carried to approve "Legal, Privacy and Information Security Issues for the New Technology World of Business" as a three credit hour continuing education course, under the course categories Risk Management and Technology and the Licensee.

Course – "Common Interest Developments: Managing Condominium Association Properties;" Author/Owner/Provider: Institute of Real Estate Management; Clock Hours: 12

Upon a motion by Commissioner Harvey, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "Common Interest Developments: Managing condominium Association Properties" as a 12 credit hour continuing education elective course.

Course – "Marketing & Leasing: Multifamily Properties;"
Author/Owner/Provider: Institute of Real Estate Management; Clock Hours: 12

Upon a motion by Commissioner Apisa, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "Marketing & Leasing: Multifamily Properties" as a 12 credit hour continuing education elective course.

Course – "Human Resource Management for the Property Manager;" Author/Owner/Provider: Institute of Real Estate Management; Clock Hours: 12

The Commissioners opined that the content of the course does not appear to apply specifically to real estate licensees, and was more generic.

Commissioner Apisa moved to deny "Human Resource Management for the Property Manager" as a continuing education elective course based on section 16-99-101(7), Hawaii Administrative Rules. Commissioner Harvey seconded the motion. The motion was voted on and unanimously carried.

Course – "Certified HAFA Specialist: Home Affordable Foreclosure Alternatives (HAFA) Certification Program;" Author/Owner: Asset Plan USA; Provider: Hawaii Association of REALTORS[®]; Course Categories: Finance, Other – Government Programs, HAFA; Clock Hours: 5

Commissioner Harvey was concerned that HAFA issues are constantly in flux and that the course materials may not be current when the course is offered. He added that five credit hours may be too much for a topic that is changing so much and so often.

Commissioner Gendrano suggested requesting the instructor disclose throughout the class that HAFA is constantly changing.

Commissioner Harvey moved to deny "Certified HAFA Specialist: Home Affordable Foreclosure Alternatives (HAFA) Certification Program" as a continuing education course, based on section 16-99-101(7), Hawaii Administrative Rules. Commissioner Loudermilk seconded the motion. The motion was voted on and unanimously carried.

Continuing Education Core Course – Update

Senior Specialist Fujimura reported on the progress of the 2011-2012 core course Part A.

Senior Specialist Fujimura reported that the first draft was received on April 4, 2011, per contract, and the course was not in a presentable condition. In the past, the first draft submitted was in much better shape. However, in this case, this first draft is more like a rough draft in its infancy stage. Staff has spent an unusual amount of time reviewing and meeting with the vendor to elevate the quality of the product. She reported that it was not well organized, not clear and not accurate.

Senior Specialist Fujimura reported that the EETF will be meeting on May 19, 2011, to go over the third revision of the first draft and provide comments as required by the terms and conditions of the agreement.

Senior Specialist Fujimura reported that Staff has agreed to assist the vendor with formatting and references to laws and rules. However, Staff has not and will not rewrite the course, but will provide the vendor, today, with a list of general comments on the whole course, along with examples illustrating the comments.

It was reported that the EETF reviewed the initial first draft with Digital Learning Center staff present. Suggestions were made to improve the first draft. However, when the revised first draft was received by Staff, these initial suggestions were not consistently incorporated in the materials, new information was added that was not in the original draft, which then increased the review time for the new information.

It was reported that deadlines have not been extended at this time and there are no requests to extend any deadlines.

Commissioner Loudermilk recommended reviewing the agreement to see what the performance requirements are and give the vendor a chance to perform, and see what the outcome is after the May 19th EETF meeting.

The Committee discussed the option of re-procuring for Part B or having both parts A and B presented in 2012.

The SEO added that there is an option of bringing a trainer here to offer a Commissioner College through ARELLO or a similar program with CLEAR, and he will speak to the Licensing Administrator about this option.
