Course – "Rental Property Management;" Author/Owner: Ginger A. Kolonick; Provider: Abe Lee Seminars; Course Category: Real Estate Law, Property Management; Clock Hours: 3

Ms. Ginger Kolonick was present. Ms. Kolonick stated that during the past ten years she has taken many continuing education courses on property management and they never address all the different types of property management.

Ms. Kolonick stated that this course covers rental management. Having personally experienced three different types of rental managers, she feels that this course is necessary.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to take this matter under advisement.

Course – "Buyer Representation 2011-2012;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law; Clock Hours: 3 (Deferred from 7/13/11 ERC)

Senior Specialist Fujimura reported that decision making on this application was deferred from the July 13, 2011, meeting. She stated that Mr. Catanzaro has addressed the Committee's concerns and integrated the Committee's suggestions into the course. Mr. Catanzaro has also acquired the Hawaii Association of REALTORS®, permission to use their forms for illustration purposes in the course.

Commissioner Cobb questioned who updates the course or assures that the course is updated when there are changes to the standard forms. Senior Specialist Fujimura replied that the provider and/or instructor are responsible for keeping the course updated. If Staff receives reports to the contrary, Staff will follow-up. Senior Specialist Fujimura added that any Commissioner is welcome to monitor any continuing education course.

Commissioner Kuriyama suggested that Staff issue a notice to all providers and instructors when HAR updates their standard forms.

Upon a motion by Commissioner Loudermilk, seconded by Commissioner Kuriyama, it was voted on and unanimously carried to take this matter under advisement.

Course – "Disclosures in Residential Transactions;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law; Clock Hours: 6 (Deferred from 7/13/11 ERC)

Senior Specialist Fujimura reported that decision making on this application was deferred from the July 13, 2011, meeting. She stated that Mr. Catanzaro has addressed the Committee's concerns and integrated the Committee's suggestions into the course. She added that Mr. Catanzaro has also increased the course to six hours as suggested by the Committee.

Upon a motion by Commissioner Loudermilk, seconded by Commission Kuriyama, it was voted on and unanimously carried to take this matter under advisement.

Course – "The Settlement Process – HUD-1, RESPA, and the GFE;"
Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law, Finance, Broker Management, Other – RESPA, Consumer Protection; Clock Hours: 3 (Deferred from 7/13/11 ERC)

Mr. David Catanzaro arrived.

Senior Specialist Fujimura reported that decision making on this application was deferred from the July 13, 2011, meeting. She stated that Mr. Catanzaro has made changes to the original submission and added more material. He has addressed the Committee's concerns and integrated the Committee's suggestions into the course.

Mr. Catanzaro stated that he has complied with all items as suggested by the Committee, as well as added material.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Cobb, it was voted on and unanimously carried to take this matter under advisement.

Course – "Foreclosure Resolution Law in Hawaii;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law, Finance, Dispute Resolution; Clock Hours: 6

Mr. David Catanzaro was present. Mr. Catanzaro stated that this is a very comprehensive law that took time to develop. He stated that with this course, he wants to make a statement to licensees regarding the new foreclosure law and who they can refer clients to. He added that this course warns licensees that this is a very complex process.

Mr. Catanzaro was asked if he will be instructing the course and about his experience with foreclosures. Mr. Catanzaro stated that he will be the instructor. Although he has never been foreclosed upon, years ago, he has worked with clients and experts in the field. Mr. Catanzaro stated that he has seen his share of foreclosures in his 30 years of experience.

Commissioner Cobb stated that she was concerned with a lay person teaching this course due to its complexity and legal implications. She noted that she has taken courses taught by attorneys that could not fully explain the process.

Mr. Catanzaro stated that he has an attorney on staff.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Cobb, it was voted on and unanimously carried to take this matter under advisement.

Instructor's Development Workshop

Hawaii Association of REALTORS® Proposal 2011-2012 IDW

Ms. Marsha Shimizu was present. Ms. Shimizu stated that per the contract with the Commission, HAR is proposing to offer two IDWs this biennium.

Ms. Shimizu stated that the first IDW will be focused on course development. The presenter has condensed the workshop from a two-day workshop to one day. She added that it is a very hands-on workshop and the students will go through the process of course development—designing, creating and validating courses and curricula. If approved, they intend to offer this IDW on September 14, 2011, in conjunction with the HAR real estate convention to utilize the meeting room space at no cost.

Ms. Shimizu reported that there are 12-14 people on the waiting list for the "T3: Training Trainers to Train" IDW and they are proposing this as their second IDW for the biennium. If approved, they intend to offer the IDW late this year or early next year.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to take this matter under advisement.

Budget and Finance Report:

Management; Clock Hours: 3

Applications

Commissioner Loudermilk moved to approve "Rental Property Management" as a three credit hour continuing education elective course, under the course categories Real Estate Law and Property Management, subject to replacement of all references to "realtor" with "licensee" in the course materials. Commissioner Kuriyama seconded the motion. The motion was voted on and unanimously carried.

Course – "Buyer Representation 2011-2012;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law; Clock Hours: 3 (Deferred from 7/13/11 ERC)

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Wada, it was voted on and unanimously carried to approve "Buyer Representation 2011-2012" as a three credit hour continuing education course, under the course categories Contracts and Real Estate Law.

Staff was asked to remind the author that where a Hawaii Association of REALTORS[®], form is used in the course materials the item should be marked with "sample" or a similar watermark as specified in HAR's July 19, 2011, letter to the author.

Course – "Disclosures in Residential Transactions;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law; Clock Hours: 6 (Deferred from 7/13/11 ERC)

Commissioner Kuriyama moved to approve "Disclosures in Residential Transaction" as a six credit hour continuing education elective course, under the course categories Contracts and Real Estate Law, subject to corrections to slide numbers 51 and 52 of the PowerPoint presentation. Specifically, bullet five of

slide 51, the cite should be corrected and bullet 2 of slide 52, the word is misspelled. Commissioner Loudermilk seconded the motion. The motion was voted on and unanimously carried.

Staff was asked to remind the author that where a Hawaii Association of REALTORS[®], form is used in the course materials the item should be marked with "sample" or a similar watermark as specified in HAR's July 19, 2011, letter to the author.

Commissioner Kuriyama felt that due to the technical nature of the subject matter, the Committee should exercise its right to have the course independently reviewed.

Commissioner Kuriyama moved to defer decision making on this application and have the course independently reviewed by a consultant pursuant to section 16-99-100(b), Hawaii Administrative Rules. Furthermore, the Education Review Committee will select the consultant. Commissioner Senter seconded the motion. The motion was voted on and unanimously carried.

Course – "Foreclosure Resolution Law in Hawaii;" Author/Owner/Provider: David Catanzaro/REMI School of Real Estate; Course Categories: Contracts, Real Estate Law, Finance, Dispute Resolution; Clock Hours: 6

Commissioner Kuriyama moved to approve "Foreclosure Resolution Law in Hawaii" as a three credit hour continuing education elective course, under the course categories Contracts, Real Estate Law, Finance and Dispute Resolution. Furthermore, due to the technical, legal nature of the subject matter and the ambiguity of this untested law, the instructor is required to co-teach the course with a qualified expert or an experienced attorney in foreclosure law. Commissioner Loudermilk seconded the motion. The motion was voted on and unanimously carried.
