"Live Webinar: Apartment Buildings – Secrets to Understand, Sell and List Them" (ARELLO/McKissock, LP) 06/12/2012

Course – "Avoiding Real Estate Fraud"; Author/Owner: Scott C. Arakaki, Esq.; Provider: Eddie Flores Real Estate Continuing Education; Course Categories: Real Estate Law, Risk Management; Clock Hours: 3 (Deferred ERC 4/11/12)

Mr. Arakaki stated he appreciated the Commissioners comments and he revised the course to reflect the following:

- 1) Elaborate on how to avoid different types of fraud by recognizing specific red flags that may arise. What does a real estate licensee do if they suspect fraud? To whom may they report their suspicions?
- 2) Review the language used on page 1, 3rd paragraph under "Why be concerned about real estate fraud?" The ERC noted that characterizing the real estate licensee as "innocent" and "unknowingly a victim or facilitator..." may not be completely apropos, as real estate licensees may not always rely on a defense of "I didn't know."

Ms. Beth Holiday was present to answer questions on her courses.

Ms. Holiday stated that these courses are about knowing and applying the laws. Applicants are not prepared for the day to day world after they pass their test and they do not know how to apply it to their business.

Course - "Cloud Computing and Mobile Technology for the Real Estate Agent"; Author/Owner: Robin Sagadraca; Provider: Abe Lee Seminars; Course Category: Technology and the Licensee; Clock Hours: 3

Mr. Robin Sagadraca was present to answer questions.

Mr. Sagadraca stated that this course will explore what cloud computing is, how it works and how it is being deployed. Additionally, this class will examine cloud computing and its relation to the rapidly expanding field of mobile technology. By learning about cloud computing and mobile technology, agents will be able to discover new and alternate ways that real estate problems can be solved and obstacles to servicing their clients.

Ms. Shimizu stated that this course addresses content, branding and trademark misuse; fair housing and Code of Ethics violations; the power of the social web and marketing. The course guides licensees through today's online landscape and how agents need to stay out of trouble and best serve the new consumers.

Mr. Wilia stated that this course provides real estate students an overview of the development of a subdivision and a condominium property regime which will assist them in guiding clients on the basic requirements.

The Commission has concerns that this course only applies to Honolulu ordinances. Mr. Wilia responded that all county ordinances are different. The Commission recommended Mr. Wilia identify the county charts used as references in the course materials.

Concerns were raised about the need to distinguish the difference between the county's recognition of condominiums as a physical build-out and the state's recognition of the condominium property regime as a division of legal ownership.
