Continuing Education: Education Evaluation Task Force

The next EETF meeting is scheduled for June 30, 2005.

Vice Chair Nishihara addressed concerns of Ms. Elizabeth Hardy that she brought up at the Laws and Rules Review Committee meeting earlier this morning regarding continuing education. Vice Chair Nishihara stated that the EETF has discussed extending continuing education hours and bringing back testing for continuing education courses and they will continue to review these issues.

Prelicense Education: Administrative Issues – Evaluations – Independent Study

Copies of evaluations of independent study courses from the following prelicense schools were distributed to the Commissioners for their information:

- Seiler School of Real Estate
- Vitousek Real Estate School
- 3. Abe Lee Seminars

A copy of an evaluation of Hawaii Academy of Real Estate's (HARE) independent study course, a copy of letter from Elizabeth Merk and a copy of an email from Janice Lind to Elizabeth Merk were distributed to the Commissioners.

Senior Specialist Fujimura stated that she spoke with Ms. Lind regarding Ms. Merk's complaints of the independent study course she completed with HARE, and Ms. Lind explained what they did to accommodate Ms. Merk. Senior Specialist Fujimura stated that there did not appear to be any possible violations of laws and rules governing prelicense schools on the part of HARE.

Commissioner Abrams stated that this is the first time that he has seen such a low evaluation of an independent study course and noted that this does not happen often and is an exception.

Vice Chair Nishihara questioned if there should be a response to Ms. Merk. SEO Kimura responded that Ms. Merk should be informed of her option to file a complaint with the Regulated Industries Complaints Office.

<u>Prelicense Instructor – Ron Fleet, REEF, Inc. dba Hawaii Institute of Real Estate, Salesperson and Broker Curricula</u>

Upon a motion by Commissioner Okawa, seconded by Commissioner Ohama, it was voted on and unanimously carried to recommend approval of Ron Fleet as a prelicense instructor for the salesperson and broker curricula.

Notice for Professional Services of Contractor to Develop the Online Prelicense Courses for Real Estate Salespersons and Brokers

Senior Specialist Fujimura reported that the Notice for Professional Services of Contractor to Develop the Online Prelicense Courses for Real Estate Salespersons and Brokers was withdrawn. She stated that three proposals were received through the procurement process and after review of the proposals, the fees are way over the budgetary allotment for this project.

She reported that she will draft a less ambitious outline for procuring services for the development of an electronic delivery of the prelicense courses.

Administration of Examinations:

Promissor

Licensing Examination Statistics

Examination statistics for April 2005 were distributed to the Commissioners for their information.

SEO Kimura noted that there is an alarming 30% passing rate for individuals taking the broker's examination. These statistics will be monitored, and hopefully an improvement will occur over time.

Commissioner Ohama noted that the instruction of the new curriculum may not be up to par yet—the low passage rate may not only be the students' failure to comprehend and retain the material, but it also may be the quality of the instruction. He noted that there are a limited number of instructors of the new broker's course.

Commissioner Ohama added that another reason for the two year rule was that it takes at least one year, maybe two, for new examination questions to be validated.

Staff will research the possibility of compiling statistics from Promissor on applicants who completed the new broker's course and the old broker's course and the resulting pass-fail percentages for testers.

March 2005 School Summary Reports

A copy of the performance summary report, by school, was distributed to the Commissioners for their information. The report is derived from statistics for first time test takers.

Uniform Section Content Outlines for Sales and Brokers Examination

Upon a motion by Commissioner Abrams, seconded by Commissioner Nishihara, it was voted on and unanimously carried to recommend approval of the updated Uniform Section Content Outlines for Sales and Brokers Examination with a target date of August 1, 2005 for publishing new forms for Hawaii testing.

Senior Specialist Fujimura reported that the May 2005 issue of the *Bulletin* will be distributed shortly. She noted that there were a few technical difficulties in getting the issue together for timely distribution.

Senior Specialist Fujimura added that the issue is already available on the web site at www.hawaii.gov/hirec and is always available on the web site before distribution of the hard copy.

SEO Kimura stated that the goal is to eventually go paperless and have the *Bulletin* distributed electronically as it will be available in a timelier fashion, may be issued more often than just quarterly, and may distribute information on issues that have immediate impact on real estate licensees.

Copies of evaluations of the Instructor's Development Workshop held on May 2, 2005, were distributed to the Commissioners for their information. Staff reported that the instructor, Deborah Long, was excellent. SEO Kimura recommended having Ms. Long conduct other workshops, possibly on ethics.

Ms. Marsha Shimizu reported that HAR has hired Ms. Long to redevelop their Essentials of Listing course. HAR will be working with Ms. Long on a long distance basis, but Ms. Long will return to Hawaii to complete the final draft.

Commissioner Ohama moved to have the Commission co-sponsor with the Hawaii Association of REALTORS®, pursuant to terms of the Commission's contract with HAR, an IDW with Deborah Long. Commissioner Abrams seconded the motion. The motion was voted on and unanimously carried.
