Senior Specialist Fujimura noted that she has been in contact with Karen Ono of the Kauai Board of REALTORS® and Ms. Ono will be discussing these evaluations with the instructor.

Applications

Substitute Instructor – Carol M. Egan, All Islands Real Estate School, Salesperson and Broker curricula

Commissioner Kagawa moved to approve Carol M. Egan as a substitute instructor for the salesperson and broker curricula. Commissioner Okawa seconded the motion.

Commissioner Loudermilk questioned item 7.b. of the application – Qualifications (professional) . . . a degree in law; licensed and practicing in the area of real estate law for at least two years in Hawaii. Senior Specialist Fujimura stated that the rule does not specify a time frame within which the practice of law occurred. Ms. Egan had previously changed the category of her qualification to item 7.a., holding a current Hawaii real estate broker's license, having a minimum of three years full-time experience in real estate in Hawaii; and meeting the current experience requirements for a broker's license. The change of category was previously distributed.

Ms. Egan stated that she is a licensed broker and has practiced real estate law. She stated that she has had her own practice since 1989 focusing on real estate law and business law in Hawaii, has provided professional services for the Department of Human Services, has been a continuing education instructor, been on the mediation committee for six years and served as the Chair for two years.

The motion was voted on and unanimously carried to approve Carol M. Egan as a substitute instructor for the salesperson and broker curricula.

At this time, Ms. Egan questioned how many of the current instructors have had to serve one year as substitute instructor and how recent is this substitute instructor requirement. Senior Specialist Fujimura responded that since 2001 there have been a handful of instructors that did substitute teaching prior to

receiving their instructor certification. Deputy Attorney General Wong stated that the rule was enacted in 1991 and amended in 2001.

Ms. Egan stated that she comes before the committee as a real estate attorney, a broker and has 30 years of teaching experience and is trying to understand the rationale behind the law. Commissioner Abrams stated that there are four categories for professional qualifications. Ms. Egan stated that she does not understand how there can be harm to the public with her credentials. Commissioner Loudermilk added that there are a variety of ways to fulfill the one year teaching requirement.

Senior Specialist Fujimura stated the EETF has been discussing revising the criteria for prelicense instructors. SEO Kimura added that any revision will require a rule change and any suggestions are welcome.
