# Continuing Education and Equivalency Statistics – 3<sup>rd</sup> Qtr FY 07

Continuing Education statistics for the first three quarters of fiscal year 2007 were distributed to the Commissioners for their information.

# **Continuing Education Core Course**

Senior Specialist Fujimura reported that the State Procurement Office has begun using their new Hawaii Electronic Procurement System (HEPS) and the quotations previously received to assist the Real Estate Commission in developing its mandatory core course curriculum for the 2007-2008 biennium can no longer be considered as we are required to utilize the HEPS system.

Staff has not been trained on the usage of HEPS; however, Senior Specialist Fujimura reported that she was invited to a demonstration/mini training session and the request for quotations for the mandatory core course was used as a demo and was placed into the HEPS system.

Senior Specialist Fujimura reported that HEPS has a list of registered vendors categorized by service provided and the request for quotation will initially go out to registered vendors domiciled in Hawaii only. If within seven days (April 17, 2007) there are no quotations received, the request will then go out to national vendors. Any qualified business can become a registered vendor by going to the State Procurement Office website and registering their business.

# **ARELLO Certification Program**

Information and FAQ's gathered from ARELLO.net regarding ARELLO's certification program was distributed to the Commissioners. SEO Kimura stated that everyone should be aware of and understand ARELLO's certification process. He reported that other professional areas utilize the ARELLO certification program, other than real estate, for distance education.

# School Summary Reports - February 2007

A copy of the February 2007 performance summary report, by school, was distributed to the Commissioners for their information. The report is derived from statistics for first time test takers.

Commissioner Kuriyama inquired if the statistical information received from Promissor is tracked. Senior Specialist Fujimura replied it is not tracked as we rarely get complaints.

Commissioner Nishihara stated that the EETF was to work on an audit system; however, nothing has been formalized. Senior Specialist Fujimura added that current staff responsibilities leaves no time to monitor prelicense courses.

Commissioner Kuriyama stated that because we are being provided the information, we should track the schools' performance. SEO Kimura stated that we could bring it up with the testing company to provide an analysis of each school. Commissioner Abrams stated that he would be more concerned about the instructors. Regarding the confidentiality of the statistics, Commissioner Abrams stated that it may be an OIP issue or it could be a provision in Promissor's contract.

Commissioner Kuriyama stated that if students are underperforming consistently some action should be taken regarding the school.

Commissioner Suiso stated that it needs to be determined if schools are producing good licensees versus producing students that are just able to pass the test.

After discussion, the Commissioners requested information on the following:

- 1. If there is a prohibition and/or confidentiality clause regarding disseminating Promissor's score reports.
- 2. Promissor to provide an analysis of each school's performance.
