Call to Order: Vice Chair Aiona called the meeting to order at 9:28 a.m., at which time quorum

was established.

Chair's Report: Vice Chair Aiona stated the Commission may move into Executive Session to

Minutes of June 15, 2007 Meeting

Upon a motion by Commissioner Loudermilk, seconded by Commissioner Abrams, it was voted on and unanimously carried to accept the minutes of the June 15, 2007, Education Review Committee meeting as distributed.

Continuing Education:

Applications

Course – "STDB Online;" Author/Owner: STDB Inc.; Provider: Hawaii CCIM Chapter; Course Category: Technology and the Licensee; Clock Hours: 3

Liz Palmer, Hawaii CCIM Chapter representative, was present to answer any questions the Commissioners may have regarding this continuing education elective course application.

Commissioner Abrams questioned if an individual would have to subscribe to gain access to this database. Ms. Palmer responded that there are levels of subscription—one can gain access to the basic level at no charge, and depending on the level to be accessed, there may be charges.

Upon a motion by Commissioner Abrams, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve "STDB Online" as a three credit hour continuing education elective course under the course category Technology and the Licensee.

Course – "Residential Property Management Basics;" Author/Owner: Scott A. Sherley; Provider: ERA School of Real Estate; Course Categories: Contracts, Property Management, Risk Management; Clock Hours: 3

Upon a motion by Commissioner Chee, seconded by Commissioner Abrams, it was voted on and unanimously carried to approve "Residential Property Management Basics" as a three credit hour continuing education elective course under the course categories Contracts, Property Management, and Risk Management.

Core Course – "Law and Agency Update 2007: A 2 Hour Core Course;" Author/Owner/Provider: REMI School of Real Estate; Course Categories: Chapter 468, HRS/Chapter 99, HAR, updates; Chapter 514A, HRS/Chapter 107, HAR, Ethics, and Agency and Disclosure; Clock Hours: 2

David Catanzaro was present to answer any questions the Commissioners may have regarding this continuing education core course application.

Senior Specialist Fujimura stated that this proposed core course will cover legislative updates from this past legislative session, as well as agency, and is being presented as Part A (2 hours) of the core course, with Part B to be submitted in 2008.

Vice Chair Aiona was concerned about the agency portion of the course and felt that it fell short. Mr. Catanzaro stated that the agency portion will cover single agency, dual agency and laws and ethics of agency. Mr. Catanzaro stated that he is willing to expand the agency portion of the course upon the Commission's advice. Mr. Catanzaro added that the laws and rules are voluminous and he had only 120 minutes, but he will redistribute the time.

Commissioner Abrams suggested that the failed and carry-over legislation portion of the course should be removed as it may confuse students. Mr. Catanzaro responded that he will take the Commission's advice and incorporate the suggestion and amend the course.

Commissioner Abrams stated that he feels the agency portion of the course is not clear on conflicts and gave several examples that may benefit students if incorporated into the course.

Senior Specialist Fujimura reported that the failed and carry-over legislation has also been included in the Commission's draft core course. SEO Kimura stated that it does not provide any education to licensees and suggested that it not be included in the core course.

Commissioner Abrams noted that there is information regarding the health coverage law included in the legislative update, and inquired where the information for the course is being gathered from. Mr. Catanzaro responded that he gathered his information from RSS feeds directly from the Legislature and also contacted the Hawaii Association of Realtors for leads. Mr. Catanzaro added that he will work on expanding the agency portion of the course and cut back on some of the legislation that is not related directly to real estate.

Vice Chair Aiona stated that she would like to see more scenarios included in the course.

Upon a motion by Commissioner Abrams, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to defer decision making on this application until the July 27, 2007, Real Estate Commission meeting, and agreed upon revisions are made.

Provider – Property Merchants, Inc. dba All Island Real Estate School; Carol Egan, Administrator

Upon a motion by Commissioner Loudermilk, seconded by Commissioner Abrams, it was voted on and unanimously carried to approve Property Merchants, Inc. dba All Islands Real Estate School as a continuing education provider.

ARELLO Certification Program

ARELLO Education Content Certification Program

The Association of Real Estate License Law Officials (ARELLO) has initiated their Education Content Certification Program and a packet of information regarding this program was distributed to the Commissioners.

ARELLO's objectives of the program are to:

- 1. Provide assurance that the content of real estate education offered meets ARELLO standards;
- 2. Provide a means by which regulatory agencies can participate on a voluntary basis to reduce the workload on an agency's education staff in reviewing course content;
- 3. Promote the recognition of content among jurisdictions by certifying course content that is generally accepted in professional real estate practice;
- 4. Ensure that course titles accurately reflect the contents of the course;
- 5. Provide guidance to providers in the continued improvement of the educational content as it pertains to professional real estate practice; and
- 6. Promote educational and ethical standards of professional real estate education.

ARELLO has requested that jurisdictions participate in the program by either:

- 1. Requiring the certification for courses taught in the jurisdiction;
- 2. Recognizing the certification by automatically approving courses that have it; or
- 3. Endorsing the certification.

Senior Specialist Fujimura stated that our current statutes allow automatic approval of ARELLO certified courses. The ARELLO Education Content Certification Program is a new, specific program offered by ARELLO, and the Commission will not be taken out of the process of reviewing and approving courses that are submitted for continuing education certification. Depending on the level of participation, the Commission may receive courses that have already received the ARELLO content certification, and may automatically have Staff approve these courses, or the submitted course may come before the Commission for review, as is done now, and the course can be approved or denied. The Commission may want to review these courses for Hawaii-specific content.

SEO Kimura stated that this program benefits States with none or little Staff or States that have no rules regulating courses.

Upon a motion by Commissioner Abrams, seconded by Commissioner Kuriyama, it was voted on and unanimously carried to **endorse** the ARELLO Education Content Certification Program. An endorsement constitutes no formal commitment to ARELLO or to providers obtaining the certification but does allow the jurisdiction to support the initiative.
