Mr. Connelley was present and addressed the committee. Mr. Connelley informed the committee that at the time of application the bond was not provided. A copy of the school's bond was submitted to the committee. Mr. Connelley also informed the committee that HIRE will be offering non-REC approved courses and providing post-licensing education to fill the void.

Chair Ball commented that it would be interesting to receive statistics on the pass/fail rate of students who take the course online vs. live.

Program of Work:

Instructor's Development Workshop

Proposal submitted by Hawaii Association of REALTORS®

Marsha Shimizu was present on behalf of HAR. Ms. Shimizu distributed for the committee's review a topic and time outline for the proposed IDW T3 Training Trainers to Train.

Specialist Fujimura informed the committee that the Commission has contracted with HAR to provide at least one IDW and one real estate-related seminar during the biennium. The Commission will co-sponsor and partially fund the approved IDW and/or seminar.

Ms. Shimizu informed the committee that the proposed IDW is a beginning level IDW which will be offered on the neighbor islands. Next year HAR would like to offer an advanced level IDW.

Ms. Shimizu further noted that the proposed IDW is one-and-a-half days long. The first day will cover teaching styles. The instructors will choose a topic and develop the topic into a presentation. On day two of the IDW, the instructors will

teach their selected topic while being video-taped. They will also be evaluated and critiqued by the other instructors attending the IDW.

Chair Ball noted that she reviewed the IDW instructor manual and the student handouts with PowerPoint presentation, appendix with handouts, forms to do presentation, evaluation forms for student evaluators, and action list for improvement. Chair Ball stated that she appreciated the attempt to provide the IDW, but noted there are problems with the proposal. Chair Ball stated that the course should be self-explanatory. It appears as though the learning events are descriptions of events rather than real events that will be used in the classroom to instruct. There were insufficient samples of quality training materials other than the text-heavy PowerPoint presentation.

Chair Ball suggested that HAR amend the course by:

Creating a syllabus for the course to include: goals and objectives, exercises to illustrate and develop skills that will actually be used in the course and when they will be used; evaluation rubric of student performance mirroring goals and objectives to be taught, so attendees will know how they will be evaluated, provide samples of quality teaching materials to be used, and eliminate the video of each student performance.

Discussion followed on condensing the IDW from one-and-a-half days to one day, especially since there may be instructors who are not beginners taking the IDW. A suggestion was to condense Module 4: Open the Class (Arriving for Class; Handling Anxiety; Greeting and Introduction; Icebreakers, Objectives and Expectations) from 75 minutes to 10 minutes, and to condense Module 6, Learning Techniques.

Specialist Fujimura noted that the author of the course is Beth Holiday. Ms Holiday previously submitted an IDW proposal to the ERC about two years ago.

Upon a motion by Commissioner Nishihara, seconded by Commissioner Gendrano, it was voted on and unanimously carried to defer action for further submission of structured information on the proposed IDW.

Proposal submitted by Eddie Flores Continuing Education, Bryan P. Andaya, Administrator

Chair Ball noted that in her review of the proposed IDW by Eddie Flores Continuing Education, she found the course content to be non-substantive. Quality materials were not provided. The course needs to be able to stand on its own merit and not on the personality of the instructor (Mr. Flores).

Suggestions for improvement of the IDW were as follows:

- 1. Develop objectives for specific skill building
- 2. Create a course syllabus
- 3. Tips lists have excellent material for PowerPoint presentation but could also be merely lists of things to do and not do. PowerPoint presentation needs to be engaging.
- 4. Provide rubrics for evaluation
- 5. Consider what it would be like if the instructor were unable to deliver the course.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Nishihara, it was voted on and unanimously carried to defer action for further

review and submission of structured material. It was also requested that staff incorporate Chair Ball's review and comments of the submitted proposals in the correspondence to both Eddie Flores Continuing Education and HAR.
