Upon a motion by Commissioner Kuriyama, seconded by Commissioner Chee, it was voted on and unanimously carried to accept the minutes of the September 10, 2008, Education Review Committee meeting as distributed.

Continuing Education: Adm

Administrative Issues

New Salesperson Licensees - 2008

Senior Specialist Fujimura reported that 79 salesperson licenses were issued in September and as of September 30, 2008, there are 1,012 new salesperson licensees in 2008. The total number of 1,012 new salesperson licensees reflects the number of licensees who are deemed as having completed the 10 hour continuing education requirement, pursuant to Section 16-99-89(c), Hawaii Administrative Rules.

Course – "Risk Management"; Author/Owner: Dearborn Real Estate Education; Provider: Russ Goode Seminars, Russ Goode – Administrator; Course Category: Risk Management; Course Hours: 3

Mr. Goode informed the committee that this is a national course which he will be teaching via a power point presentation and discussion. The course was written as a six hour course. Mr. Goode noted that he will not be giving the tests offered in the textbook to cut down on the hours.

The Commissioners expressed their concerns over the deletion of the agency section.

Mr. Goode replied that he will be providing only a summary of the agency section, because the Commission included "Agency" as part of its core course. If the Commission requests that he include the agency section information, he is willing to do so

Upon a motion by Commissioner Abrams, seconded by Commissioner Chee, it was voted on and unanimously carried to approve the course "Risk Management" as a three credit hour continuing education elective course, under the course category Risk Management, subject to the inclusion of the Agency section.

Course – "Environmental Issues in Your Real Estate Practice"; Author/Owner: Dearborn Real Estate Education; Provider: Russ Goode Seminars, Russ Goode – Administrator; Course Categories: Property Management, Risk Management; Course Hours: 3

Mr. Goode reported that the "Environmental Issues in Your Real Estate Practice" course was written as a 6 hour course. The course will be presented via a power point presentation and discussion. At the end of each chapter there are resources to go to. The class will be taught as a red flags course and is not meant to solve the problems, but rather, how to recognize problems.

Commissioner Gendrano stated that she was impressed with the summary of the course and how it is broken down.

Upon a motion by Commissioner Aiona, seconded by Commissioner Gendrano, it was voted on and unanimously carried to approve the course "Environmental Issues in Your Real Estate Practice" as a three credit hour continuing education elective course, under the course category of Property Management.

Course – "The Updated Real Estate Law Manual, Volume One, Seminar; Author/Owner: Hawaii State Bar Association; Provider: University of Hawaii at Manoa, Outreach College; Course Categories: Contracts and Real Estate Law; Course Hours: 3

Ms. G. Hisae Ishii-Chang of HSBA informed the committee that this is a very important and valuable course. The Updated Real Estate Law Manual, Volume One, is actually a series of 4 manuals which are leading publications on real estate law in Hawaii. The authors have agreed to update the manuals one at a time beginning with Volume One. If approved, CE credit will be offered for the morning session. Although the course is geared towards attorneys, it will benefit the real estate licensees and familiarize them with terminology.

Chair Ball expressed that she thought the course was an excellent course, but had concerns as to the redundancy of the information to the Commission's prelicensing course. The course seems to cover identical material, and CE courses should be designed to exceed minimum entry level competency and improve a licensee's competency, or professional standards and practice.

Ms. Ishii-Chang responded that the course is an update, and is the latest information available, and it is not redundant to the Commission's prelicensing course.

Upon a motion by Commissioner Chee, seconded by Commissioner Abrams, it was voted on and unanimously carried to approve the course "The Updated Real Estate Law Manual, Volume One, Seminar" as a three credit hour continuing education elective course, under the course categories of Contracts and Real Estate Law.
