Minutes of Previous Meetings

Upon a motion by Commissioner Loudermilk, seconded by Commissioner Sherley, it was voted on and unanimously carried to accept the minutes of the February 8, 2012, Laws and Rules Review Committee meeting as circulated.

Program of Work: FY 12

Legislative and Government Participation Report

Legislative Report No. 2 was distributed to the Commissioners for their information.

Senate Bill No. 2089, S.D.1, Relating to Transient Accommodations. SEO Fujitani reported that this bill intends to require any nonresident owner who operates a transient accommodation located in the nonresident owner's private residence to employ a real estate broker or salesperson. The Commission was in consensus that this bill remain with the Department of taxation.

Senate Bill No. 3002, S.D.2, Relating to Real Estate Brokers and Salespersons. SEO Fujitani reported that this bill attempts to strip away RICO's and the Commission's policy and powers to protect the consumers.

Mr. Myoung Oh from the Hawaii Association of REALTORS® ("HAR") was present to answer questions the Commissioners may have. Mr. Oh stated that HAR regrets not providing the Commissioners with a draft of the bill before the bill was introduced. HAR did not initiate this bill, but will support the bill and push to move it forward.

The Commissioners had some concerns about HAR's support of a bill which Prudential Location's broker-in-charge and HAR's Government Affairs Committee chairperson Brian Benton admittedly said would attempt to change a misrepresentation charge that rarely, if ever, occurs and that this bill was drafted to protect the licensee and <u>not</u> the consumer. When asked whether there are cases illustrating the need to change the current statute. Mr. Oh responded that he cannot answer that question. He also stated that Senator Slom asked the same question which HAR could not answer.

Mr. Oh informed the Commissioners that he will bring up the Commission's concerns to the Committee.
