At this time, SEO Kimura reported that there currently is a national trend by federal agencies to look in to real estate. He has been receiving information from other states that presently it is not a good time to make dramatic changes to laws or rules or to the practice of real estate organizations, especially if it borders on antitrust, reducing consumer protection, consumer relationships, etc.

Open Forum: Karen Iwamoto, HAR, reported that there is an issue of discrimination on the basis of gender identity and there is a need for education as this is a delicate issue. She stated that HAR will be working on a disclosure statement. She stated that this issue was highly lobbied by certain groups at the legislature and she wanted to know if there have been any cases on this issue.

SEO Kimura suggested that Ms. Iwamoto consult with the Civil Rights Commission.

At this time, Ms. Elizabeth Hardy, a licensee, commented on real estate continuing education. She stated that there is a need for higher standards of education—the mandatory education requirements are too low. She stated that she recently completed a few continuing education courses that were excellent, but there were not tests—the classes are too passive.

Chair Okawa responded that the Education Review Committee has oversight of education and she will relay her comments to the Chair and Vice Chair of that committee.

SEO Kimura thanked Ms. Hardy for her excellent comments. Ms. Hardy reiterated that the courses are excellent, but she is a proponent for testing.
