# Subcommittee on Agency and other Related Issues Ad Hoc Committee on Consumer-Broker Relationships

At the recent ARELLO Midyear Meeting, there was discussion on how agency was handled by the various jurisdictions. They also discussed how information was disseminated to the licensees.

Chair Abrams will follow up with the various jurisdictions on how they advertise information to their licensees and the public.

Chair Abrams reported that British Columbia intends to provide a handbook on agency which would address standards of practice and the use of agency. The trend for the Canadian Task Force is for all provinces to educate their licensees. Chair Abrams reported that he will be monitoring the progress of the Canadian Task Force. The next ad hoc committee meeting is scheduled for June 23, 2006.

# Subcommittee on Applicants with Criminal/Financial/Legal Background Issues; Criminal History Record Checks

The following information was distributed to the Commissioners for their information:

Most states have a criminal data bank and have an agreement with the FBI to do a background check, for a fee. The Hawaii Criminal Justice Data Center ("HCJDC") has a site that allows the public to search for criminal history records. There is no charge to browse. New users are charged \$1 to set up an account. The \$1 set up fee is waived for State agencies. This will allow you to perform a search. It will notify you if a record is found and you have the option to purchase the record for \$13. The records go back seven to ten years.

Promissor does background finger printing checks for some of its clients. They are able to get the results back within four hours. The State of Florida has 400,000 licensees. They had to make arrangements to have the machines located at the test center.

Condominium Specialist Grupen reported that administration does not have a problem if the Commission wished to subscribe to HCJDC's records search. If a record is found, the cost involved in obtaining the record would have to be borne by the trust funds. The additional costs may also be passed on to the applicant.

A great number of Hawaii licensees are licensed in another state or may have relocated from another state in which they may have been convicted of a crime.

The Commission would also like to move towards electronic databases which would hold all of the information from the beginning of the process until the applicant becomes licensed.

The Commission could also include condominium information also, such as individuals hired by CMAs. The Commission will continue to look at this issue.

The Deputy Attorney General informed the Commissioners that if they decided to follow what Kentucky was doing, they would need to promulgate rules to that effect.

Commissioner Ball stated that she would like applicants to know ahead of taking the prelicensing class that they can request a preliminary approval from the Commission if they have a prior conviction. The schools do not appear to be notifying the applicants of their right to request a preliminary decision before the applicant signs up for the class.

Commissioner Kuriyama said that there were two issues up for discussion. The first would be if prior notice was given to the applicant of

their option to request preliminary approval. The second issue is whether or not the Commission would allow anyone that is on probation/parole to take the exam.

The Commission would like to have the finger printing and background check completed prior to applying for a license or even before signing up for the prelicensing course.

It is the Commission's policy that the schools are to give notice up front to the candidates for licensure prior to signing an agreement to take the prelicensing classes.

There were a lot of people who were incarcerated in Nevada who were applying for a license. Nevada passed law stating that they would not issue a license if the person were incarcerated.

It was suggested that the schools be required to hand out a memo, informing them of the right to request a preliminary decision, to every applicant prior to accepting any fees. If the applicant is convicted of a crime, is on parole, or probation, they may want to consider appearing before the Commission to request a preliminary decision prior to signing up for the prelicensing course.
