Program of Work, FY08:

Licensing, Registration and Certification Administration

An excerpt from the latest Geographic Report of Current Licenses as of October 15, 2007 was distributed to the Commissioners for their information. There are 20,460 real estate licensees.

Rule Making, Chapter 99, Hawaii Administrative Rules – Real Estate Brokers and Salespersons

A copy of page 7 of the <u>Maine Real Estate News</u>, Fall 2007 issue, was distributed to the Commissioners for their information. Licensees in the State of Maine voluntarily report the completion of their continuing education requirements. The State of Maine also conducts random audits to ensure that the licensees have completed their continuing education requirements. A Maine licensee can remain inactive for six years before their have to retake the licensing examination.

A copy of the Oregon Real Estate Agency's Notice of Permanent Rule, dated June 29, 2007, was distributed to the Commissioners for their information. The rule limits the delegation of authority of a principal broker for advertising that "originates in a branch office" to a principal broker who manages that branch office. A real estate broker who is not a principal broker cannot be delegated authority for advertising. Delegation of authority must be in the written policy.

The Committee deferred to the Ad Hoc Committee on Internet Advertising to look into the issue of licensees having and advertising on their own personal websites.

Information on the Advanced Real Estate Practices Course Requirement from the Oregon Real Estate Agency was distributed to the Commissioners for their information.

It was noted that more states are moving towards post-licensing education requirements.
