SEO's Report:

Minutes of Previous Meetings

Upon a motion by Commissioner Ball, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to accept the minutes of the December 10, 2008, Laws and Rules Review Committee meeting as circulated.

At this time, the SEO reminded the Commissioners to submit their availability calendars if they have not already done so.

Program of Work, FY09:

Case Law Review

A copy of the West Law narrative of the Supreme Court of Hawaii case Hawaii Insurers Council v. Linda Lingle, Governor et al. was distributed to the Commissioners for their information.

Special Issues:

Supreme Court Rule Amendments

Senior Specialist Fujimura reported that she recently attended a meeting with Hawaii Association of REALTORS® ("HAR") representatives and other interested parties regarding the issue of unauthorized practice of law. She reported that HAR is planning to introduce legislation that will affect section 467-7, Hawaii Revised Statutes, worded as follows "...No person within the purview of this chapter shall act, assume to act, or advertise as a real estate broker or real estate salesperson without a license previously obtained under and in compliance with this chapter and the rules and regulations of the real estate commission; provided that any licensed real estate broker or real estate salesperson in good standing under this chapter and applicable real estate commission rules shall not be deemed to be engaged in the practice of law when providing services for which a license is required under this chapter."

The HAR wanted to inform the interested parties. The legislation may be redundant if the Supreme Court comes out with a ruling on this issue.

The Chair inquired if HAR is seeking the Commission's support on their proposed bill. Senior Specialist Fujimura responded that there has been no formal request.

Questions were raised on how the judiciary may view the bill.

The Chair requested that this issue be included for discussion at the next meeting and requested to review the Supreme Court's proposed language.

Senior Specialist Fujimura reported that other parties at the meeting were satisfied with the process and were content to wait for the Supreme Court ruling.

The Deputy Attorney General reminded the Committee that the interest of the HAR is not necessarily the interest of the Commission.

The Chair stated it is based on whether or not it is good for the consumer.
