Chair's Report:	The Chair announced that the Committee may move into executive session to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with Section 92-5(a)(4), HRS.
	Commissioners Suiso, Kuriyama and Gendrano were excused from today's meeting. Prior notice of their non-attendance was received.

SEO's Report:	The 2010 Real Estate Commission meeting schedule for the months January through June were distributed for informational purposes. It was requested that Commissioners inform staff of any conflicts with the meeting dates.
	Minutes of Previous Meetings
	Upon a motion by Commissioner Loudermilk, seconded by Commissioner Nishihara, it was voted on and unanimously carried to accept the minutes of the October 14, 2009, Laws and Rules Review Committee meeting as circulated.
Program of Work, FY10:	Subcommittee on Background Issues and Criminal History Records
	Electronic fingerprinting frequently asked questions provided by the Florida Department of Business Professional Regulation was distributed for informational purposes along with a copy of HRS §846-2.7, Criminal history record checks.
	Commissioner Ball noted in Florida both its examination services and electronic fingerprinting are contracted by the exam vendor.
	Specialist Endo reported that electronic fingerprinting is included in our contract with PSI. If Hawaii was to implement the electronic fingerprinting with PSI, it would only be offered at its Hawaii test locations as not all PSI mainland locations have the capability.
	It was reported that the subcommittee on background issues and criminal history records check researched the mechanics of the fingerprinting process which were reported to the Laws and Rules Review Committee at previous meetings.
	Commissioner Nishihara noted that if fingerprinting is being conducted by other boards within PVL, it would be ideal for the Real Estate Commission to handle the process in the same manner. In previous meetings it was agreed that the cost of fingerprinting would be borne by the applicant.
	Commissioner Loudermilk noted that in reviewing HRS §846-2.7, it appears that currently criminal history record checks may be conducted by DCCA on applicants for private detective or private guard licensure as provided by section 463-9. This is the only board/program affecting PVL noted in HRS §846-2.7.
