A copy of the final draft was distributed to the Commissioners for their review and comment.

Discussion ensued about the appropriateness of using the term, "DROA", as licensees have discontinued the use of the DROA form and are using "Purchase Contracts." The letter will be revised to reflect this change. Also, the paragraph referring to complaints filed with RICO was deleted, as there is no direct information that the complaints cited are a result of the unlawful practice of law.

The Commissioners asked Myoung Oh of the Hawaii Association of REALTORS if he had heard if the Hawaii Supreme Court had extended the deadline to file comments regarding the proposed rule changes. Mr. Oh said that he had heard the Hawaii State Bar Association is requesting an extension and is trying to work it out with other affected groups to request an extension.

Upon a motion by Commissioner Ball, seconded by Commissioner Aiona, it was voted on and unanimously carried to approve the finalization of the letter to the Hawaii Supreme Court with the revisions as discussed.
