Program of License Renewal

Work, FY08:

It was reported that the Professional and Vocational Licensing Division has preliminarily approved subject to the Commission's direction the mailing of license renewal reminder cards in lieu of the paper renewal applications to promote a paperless renewal. Individuals may still call PVL's Licensing Branch to request a paper renewal if desired.

Upon a motion by Commissioner Loudermilk, seconded by Commissioner Aiona, it was voted on and unanimously carried to approve the mailing of real estate license renewal reminder cards in lieu of the paper renewal applications to promote a paperless renewal.

Commissioner Nishihara questioned whether there will be a discount for online renewals.

Acting SEO Fujitani replied that although the discount figures have not been finalized it appears that a discount similar in amount to the 2006 real estate renewal cycle will be offered. Once that information is provided from the Licensing Administrator staff will bring the issue to the Commission.

A copy of the County of Kauai Planning Department's New Release, dated April 1, 2008, regarding transient vacation rental applications was distributed to the Commissioners for their information.

<u>Open Forum:</u> Acting SEO Fujitani informed the committee that during the 2006 real estate renewal more than 80% of real estate licensees renewed their real estate license online. The goal is to increase that percentage this renewal period.

Commissioner Ball noted that she does not want to exclude those licensees who do not have access to either online renewal due to lack of internet capabilities or due to lack of printing capabilities.

Acting SEO Fujitani informed the committee that staff will be offering its neighbor island renewal workshop which will give licensees an opportunity to meet with staff, submit their renewals in person, and also renew their license online. Licensees may also contact the division's Licensing Branch and request the paper renewal be sent to them.

Commissioner Loudermilk questioned whether the broker dependency will still be a problem this renewal cycle.

Acting SEO Fujitani responded that the dependency issue will always remain a problem because all active salesperson licenses are dependent on their broker. Principal Brokers and brokers-in-charge need to renew their individual licenses, as well as their brokerage firm's license, and complete their CE requirement prior to any associated licensee successfully renewing.
