Course certification expires and must be recertified prior to the end of each even-numbered year; failure to recertify will result in forfeiture of the course certification. **The recertification deadline is November 30 of each even-numbered year.**

#### **Submit all of the following:**

- A completed Application for Real Estate Prelicense Education Instructor Recertification form. Recertification applications must include updated information. Please submit an updated RESUME.
- Copy of Instructor Development Workshop (IDW) completion certificate. If already on file, please indicate when IDW was completed.
- Examination Score Report for Instructor's Exam. A prelicense education instructor must take and pass an instructor's exam every three years. If you have taken and passed the exam within the three year period preceding this application, and your examination score report is already on file, please indicate the date of the exam.
