C. Petitions for Reservation of Water in Water Management Areas

- **Res - OA93-1** - The State Department of Agriculture (DOA) filed a complete petition for reservation of 47.60 mgd of water flowing in Waiahole Ditch for agricultural uses on lands in Central and Windward Oahu.
- **Res - OA94-2** - The Office of Hawaiian Affairs' Committee on Land and Sovereignty has filed a complete petition to reserve 11 mgd of water from the Waiahole Ditch for present and future Hawaiian uses in the Waiahole area.
- **Res - OA94-3** - The Kahaluu Neighborhood Board, Waiahole Waikane Community Association and the Hakipuu Ohana have filed a complete petition for the reservation of all of the water from the Waiahole Ditch that is developed on the Windward side of Oahu, for agricultural uses.
- **Res - OA94-4** - The Kamehameha Schools/Bernice Pauahi Bishop Estate has filed a complete petition to reserve all of the waters originating from the ahupua'a of Waiawa (estimated to be 4.2 mgd) that flow in the Waiahole Ditch. The stated purpose is to serve future development on seven parcels of land in the Waiawa area.
- **Res - OA95-1** - The State Department of Hawaiian Home Lands has filed a complete petition to reserve an estimated 410,000 gallons per day of water from Waiahole Stream to serve its beneficiaries on five parcels of land (some 82 acres) in Waiahole.
- **Res - OA95-2** - The State Division of State Parks has filed a water reservation of an estimated 0.125 mgd of water from Kahana Stream to serve agricultural programs and residential lessees' subsistence agricultural permits in Kahana Valley State Park. This reservation is not presently part of the Waiahole Ditch combined contested case.
- **Res - OA97-2** - The State Department of Hawaiian Home Lands has filed a completed petition to reserve an additional 2,303 mgd of groundwater from the Waipahu-Waiawa Aquifer System for foreseeable needs in the Waianae, Ewa, Honolulu, and Koolau-poko Districts.
- **Res - OA97-3** - The State Department of Hawaiian Home Lands has filed a completed petition to amend Administrative Rule 13-171-62 to reduce the reservation for the Waimanalo Aquifer System by 0.027 mgd. (This petition was made pursuant to the Commission's action at the June 5, 1997 meeting wherein 0.027 mgd of ground water from the Waipahu-Waiawa Aquifer System was allocated for Waimanalo homestead areas.)

D. Petitions for the Designation of Water Management Areas

- **Surface Water Management Area, Ahupuaa of Punaluu** - On January 20, 1994, the Punaluu Community Association (PCA) filed a petition "in order to protect surface water including stream flow, to guarantee the statutory rights of kuleana land owners as well as the riparian and appurtenant rights of others and also to preserve and protect the agricultural base and natural habitats which depend on such surface water." Moreover, PCA alleges ongoing "serious disputes". On March 16, 1994, the Commission approved continuing the designation process to investigate and determine the need for designation.
- **Surface Water Management Area, Na Wai Eha** - On December 6, 2006, Earthjustice, representing Hui o Na Wai Eha and Maui Tomorrow Foundation, Inc. filed a petition requesting that the Commission either: (1) recognize the watersheds of Waihee, Waiehu, Iao, and Waikapu Streams (collectively, Na Wai Eha) as part of the existing Iao Ground Water Management Area, or (2) designate the Na Wai Eha Surface-Water Hydrologic Units as a surface water management area. The chairperson consulted with the County of Maui's mayor, council, and water department prior to making a recommendation to the Commission regarding the proposed designation. The Commission, on February 21, 2007 approved the chairperson's recommendation to continue the designation process, which includes publicizing and holding a public hearing, initiating and completing investigations, completing findings of fact, further consultation with the Mayor, County Council, and the Department of Water Supply, and final Commission action.

E. Contested Case Hearings Pending at the Commission:

- **CCH-OA95-1** - In the Matter of Water Use Permit Applications, Petitions for Interim Instream Flow Standard Amendments, and Petitions for Water Reservations for the Waiahole Ditch Combined Contested Case Hearing. Supreme Court No. 24873 (June 21, 2004) (referred to as "Waiahole II Remand".) The Commission's Findings of Fact, Conclusions of Law, and Decision and Order in the Waiahole II Remand proceedings was issued on July 13, 2006. Hakipuu Ohana and Ka Lahui Hawaii and Hawaii's Thousand Friends filed Notices of Appeal on August 11, 2006.
 - **CCH-MA05-1** - In the Matter of Water Use Permit Applications for the Iao Ground Water Management Area Basal Source Contested Case Hearing. Concerning only WUPAs 702 & 707, Shaft 33 (Well No 5330-05). The Commission's Findings of Fact, Conclusions of Law, and Decision and Order was issued on January 31, 2007. Petition for reconsideration filed by Maui Department of Water Supply on February 2, 2007. Deadline for responses was February 23, 2007. The Commission's response to Maui Department of Water Supply's petition was issued on March 21, 2007, only granting the change to references of I'ao to the 'Iao.
 - **CCH-MA06-1** - In the Matter of Water Use Permit Applications for the Iao Ground Water Management Area High-Level Sources and the Petition to Amend Interim Instream Flow Standards of Waihee, Waiehu, Iao & Waikapu Streams Contested Case Hearing. On hold pending resolution of CCH-MA06-2.
 - **CCH-MA06-2** - In the Matter of Complaint C04-31 Regarding Waste of Surface Water, Wailuku, Maui. On October 11, 2006, the Mediator filed a report stating that "no agreement was reached." A prehearing conference and field visit was scheduled for November 13, 2006. A hearing on the Parties' Motion for Reconsideration of Minute Order Number 5 was held on December 12, 2006. A status conference was held on January 22, 2007. On February 20, 2007, Hui o Na Wai Eha and Maui Tomorrow Foundation, Inc. filed a motion and petition to disqualify Yvonne Izu, Esq., former Deputy Director of the Commission on Water Resource Management, from representing Hawaiian Commercial & Sugar Co. in this case and its related case (CCH-MA06-1). The deadline to file a written response was March 7, 2007. A hearing on the motion and petition was held on March 13, 2007. The Hearings Officer issued his recommendations to the Commission on March 22, 2007. The deadline to file written responses was April 9, 2007. On April 5, 2007, Yvonne Izu voluntarily withdrew as counsel for Hawaiian Commercial & Sugar Company (HC&S) in both CCH-MA06-01 and CCH-MA06-02. Therefore, the Motion and Petition for Declaratory Ruling Re Disqualification of Counsel and the request by Ms. Izu for written permission to represent HC&S are both moot, and the proposed recommendations by the Hearings Officer to the Commission on both of these matters were withdrawn. The contested case hearing will be scheduled at a later date.
