C. Petitions for Reservation of Water in Water Management Areas

- **Res - OA93-1** - The State Department of Agriculture (DOA) filed a complete petition for reservation of 47.60 mgd of water flowing in Waiahole Ditch for agricultural uses on lands in Central and Windward Oahu.
- **Res - OA94-2** - The Office of Hawaiian Affairs' Committee on Land and Sovereignty has filed a complete petition to reserve 11 mgd of water from the Waiahole Ditch for present and future Hawaiian uses in the Waiahole area.
- **Res - OA94-3** - The Kahaluu Neighborhood Board, Waiahole Waikane Community Association and the Hakipuu Ohana have filed a complete petition for the reservation of all of the water from the Waiahole Ditch that is developed on the Windward side of Oahu, for agricultural uses.
- **Res - OA94-4** - The Kamehameha Schools/Bernice Pauahi Bishop Estate has filed a complete petition to reserve all of the waters originating from the ahupua'a of Waiawa (estimated to be 4.2 mgd) that flow in the Waiahole Ditch. The stated purpose is to serve future development on seven parcels of land in the Waiawa area.
- **Res - OA95-1** - The State Department of Hawaiian Home Lands has filed a complete petition to reserve an estimated 410,000 gallons per day of water from Waiahole Stream to serve its beneficiaries on five parcels of land (some 82 acres) in Waiahole.
- **Res - OA95-2** - The State Division of State Parks has filed a water reservation of an estimated 0.125 mgd of water from Kahana Stream to serve agricultural programs and residential lessees' subsistence agricultural permits in Kahana Valley State Park. This reservation is not presently part of the Waiahole Ditch combined contested case.
- **Res - OA97-2** - The State Department of Hawaiian Home Lands has filed a completed petition to reserve an additional 2,303 mgd of groundwater from the Waipahu-Waiawa Aquifer System for foreseeable needs in the Waianae, Ewa, Honolulu, and Koolaupoko Districts.
- **Res - OA97-3** - The State Department of Hawaiian Home Lands has filed a completed petition to amend Administrative Rule 13-171-62 to reduce the reservation for the Waimanalo Aquifer System by 0.027 mgd. (This petition was made pursuant to the Commission's action at the June 5, 1997 meeting wherein 0.027 mgd of ground water from the Waipahu-Waiawa Aquifer System was allocated for Waimanalo homestead areas.)

D. Petitions for the Designation of Water Management Areas

- **Surface Water Management Area, Ahupuaa of Punaluu** - On January 20, 1994, the Punaluu Community Association (PCA) filed a petition "in order to protect surface water including stream flow, to guarantee the statutory rights of kuleana land owners as well as the riparian and appurtenant rights of others and also to preserve and protect the agricultural base and natural habitats which depend on such surface water." Moreover, PCA alleges ongoing "serious disputes". On March 16, 1994, the Commission approved continuing the designation process to investigate and determine the need for designation.
- **Surface Water Management Area, Na Wai Eha** - On December 6, 2006, Earthjustice, representing Hui o Na Wai Eha and Maui Tomorrow Foundation, Inc. filed a petition requesting that the Commission either: (1) recognize the watersheds of Waihee, Waiehu, Iao, and Waikapu Streams (collectively, Na Wai Eha) as part of the existing Iao Ground Water Management Area, or (2) designate the Na Wai Eha Surface-Water Hydrologic Units as a surface water management area. The chairperson consulted with the County of Maui's mayor, council, and water department prior to making a recommendation to the Commission regarding the proposed designation. The Commission, on February 21, 2007 approved the chairperson's recommendation to continue the designation process, which includes publicizing and holding a public hearing, initiating and completing investigations, completing findings of fact, further consultation with the Mayor, County Council, and the Department of Water Supply, and final Commission action. Notice was published and a public hearing was held at the J. Walter Cameron Center in Wailuku on April 26, 2007, to hear public testimonies regarding the proposed designation. A draft Findings of Fact was completed and there was further consultation with the County. The Commission, on March 13, 2008, designated the Waihee, Waiehu, Iao, and Waikapu Surface Water Hydrologic Units as surface water management areas. A public notice setting the starting date to submit water use permit applications was issued on April 30, 2008. Existing users have one (1) year to file to continue their existing use status.

E. Contested Case Hearings Pending at the Commission:

- **CCH-MO97-1** - In the Matter of Water Use Permit Application filed by Kukui (Molokai), Inc. Well #17 (Kualapuu System, Central Sector, Molokai Aquifer) Contested Case Hearing. Supreme Court No. 24856. The Supreme Court issued its Opinion on December 26, 2007.
 - **CCH-OA95-1** - In the Matter of Water Use Permit Applications, Petitions for Interim Instream Flow Standard Amendments, and Petitions for Water Reservations for the Waiahole Ditch Combined Contested Case Hearing. Supreme Court No. 24873 (June 21, 2004) (referred to as "Waiahole II Remand".) The Commission's Findings of Fact, Conclusions of Law, and Decision and Order in the Waiahole II Remand proceedings was issued on July 13, 2006. Hakipuu Ohana and Ka Lahui Hawaii and Hawaii's Thousand Friends filed Notices of Appeal on August 11, 2006.
 - **CCH-MA06-1** - In the Matter of Water Use Permit Applications for the Iao Ground Water Management Area High-Level Sources and the Petition to Amend Interim Instream Flow Standards of Waihee, Waiehu, Iao & Waikapu Streams Contested Case Hearing. Closing Arguments before the hearings officer were held on March 4, 2008. Hawaiian Commercial and Sugar Company's Motion to Reopen Evidence and Offer of Proof was approved on August 25, 2008. On August 25, 2008, the Office of Hawaiian Affairs (OHA) filed a Motion to Supplement the Record. The evidentiary hearing and hearing on OHA's Motion to Supplement the Record were held on Tuesday, October 14, 2008, at 9:00 a.m. The Parties' Proposed Findings of Fact, Conclusions of Law and Decision and Order are due on Friday, December 5, 2008.
