The Commission on Water Resource Management is currently updating the Water Resource Protection Plan (WRPP). Last updated in 2008, the WRPP is a foundational component of the Hawaii Water Plan. It contains information on sustainable yields, instream flow standards, as well as other guiding principles for CWRM's management of Hawaii's water resources.

C. Petitions for Reservation of Water

- Res - OA93-1** - The State Department of Agriculture (DOA) filed a petition for reservation of 47.60 mgd of water flowing in Waiahole Ditch for agricultural uses on lands in Central and Windward Oahu.
- Res - OA94-2** - The Office of Hawaiian Affairs' Committee on Land and Sovereignty has filed a petition to reserve 11 mgd of water from the Waiahole Ditch for present and future Hawaiian uses in the Waiahole area.
- Res - OA94-3** - The Kahaluu Neighborhood Board, Waiahole Waikane Community Association and the Hakipuu Ohana have filed a petition for the reservation of all of the water from the Waiahole Ditch that is developed on the Windward side of Oahu, for agricultural uses.
- Res - OA94-4** - The Kamehameha Schools/Bernice Pauahi Bishop Estate has filed a petition to reserve all of the waters originating from the anupapa of Waiawa (estimated to be 4.2 mgd) that flow in the Waiahole Ditch. The stated purpose is to serve future development on seven parcels of land in the Waiawa area.
- Res - OA95-1** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 410,000 gallons per day of water from Waiahole Stream to serve its beneficiaries on five parcels of land (some 82 acres) in Waiahole.
- Res - OA95-2** - The State Division of State Parks has filed a water reservation of an estimated 0.125 mgd of water from Kahana Stream to serve agricultural programs and residential lessees' subsistence agricultural permits in Kahana Valley State Park. This reservation is not presently part of the Waiahole Ditch combined contested case.
- Res - OA97-2** - The State Department of Hawaiian Home Lands has filed a petition to reserve an additional 2.303 mgd of groundwater from the Waipahu-Waiawa Aquifer System for foreseeable needs in the Waianae, Ewa, Honolulu, and Koolau-poko Districts.
- Res - 719** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 1.772 mgd of groundwater from the Kamaole Aquifer System Area.
- Res - 720** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.03 mgd of groundwater from the Kawaipapa Aquifer System Area.
- Res - 721** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.182 mgd of groundwater from the Honokowai Aquifer System Area.
- Res - 722** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.025 mgd of groundwater from the Kekaha Aquifer System Area.
- Res - 723** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.004 mgd of groundwater from the Anahola Aquifer System Area.
- Res - 724** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 222 mgd of groundwater from the Maunukona Aquifer System Area.
- Res - 725** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.444 mgd of groundwater from the Pahoa Aquifer System Area.
- Res - 726** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.525 mgd of groundwater from the Hilo & Keauau Aquifer System Areas.
- Res - 727** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 1.65 mgd of groundwater from the Keauhou Aquifer System Area.
- Res - 728** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.02 mgd of groundwater from the Kalae Aquifer System Area.
- Res - 729** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 0.033 mgd of groundwater from the Hilo Aquifer System Area.
- Res - 998** - The State Department of Hawaiian Home Lands has filed a petition to reserve an estimated 3.398 mgd of groundwater from the Keauhou Aquifer System Area for all their foreseeable needs in the Kona District.

D. Petitions for the Designation of Water Management Areas

- Ground Water Management Area, Keauhou Aquifer System Area** - On September 13, 2013 the National Park Service and Kaloko-Honokohau submitted a petition to designate the Keauhou Aquifer System Area as a Ground Water Management Area. On October 16, 2013, the Commission extended its review of the petition and necessary investigations through December 2014. On December 10, 2014, the Commission extended the review and investigations to May 30, 2015.

E. Contested Case Hearings Pending at the Commission:

- CCH-MO97-1** - In the Matter of Water Use Permit Application filed by Kukui (Molokai), Inc. Well #17 (Kualapuu System, Central Sector, Molokai Aquifer) Contested Case Hearing. Supreme Court No. 24856. The Supreme Court issued its Opinion on December 26, 2007.
- CCH-MA06-1** - In the Matter of Water Use Permit Applications for the Iao Ground Water Management Area High-Level Sources and the Petition to Amend Interim Instream Flow Standards of Waihee, Waiehu, Iao & Waikapu Streams Contested Case Hearing. Closing Arguments before the hearings officer were held on March 4, 2008. Hawaiian Commercial and Sugar Company's Motion to Reopen Evidence and Offer of Proof was approved on August 25, 2008. On August 25, 2008, the Office of Hawaiian Affairs (OHA) filed a Motion to Supplement the Record. The evidentiary hearing and hearing on OHA's Motion to Supplement the Record were held on Tuesday, October 14, 2008, at 9:00 a.m. The Parties filed their Proposed Findings of Fact, Conclusions of Law and Decision and Order on Friday, December 5, 2008. The Hearings Officer's Proposed Findings of Fact, Conclusions of Law and Decision and Order was issued on April 9, 2009. The Parties filed written exceptions to the Proposed Findings of Fact, Conclusions of Law and Decision and Order on May 11, 2009. The Commission conducted a site visit to various locations relating to the contested case hearing on October 14, 2009. On October 15, 2009, the Commission heard oral arguments on the written exceptions to the Hearings Officer's Proposed Findings of Fact, Conclusions of Law and Decision and Order at 9:00 a.m. at Kanda Hall, Iao Congregational Church, 2371 W. Vineyard Street, Wailuku, Hawaii 96793. The Commission's Findings of Fact, Conclusions of Law, and Decision and Order was issued on June 10, 2010. Office of Hawaiian Affairs and Hui O Na Wai Eha and Maui Tomorrow Foundation filed Notices of Appeal with the Intermediate Court of Appeals on July 12, 2010. The County of Maui Department of Water Supply filed a Notice of Cross-Appeal on July 26, 2010. The Supreme Court issued its Decision and Concurring Opinion on August 15, 2012. The Commission's June 10, 2010 Findings of Fact, Conclusions of Law and Decision and Order was vacated and remanded to the Commission for further proceedings. On May 22, 2013, the Commission delegated authority to the Chairperson to appoint a hearings officer for the contested case hearing on remand. Dr. Lawrence H. Mike was appointed by the chair on July 15, 2013. On September 24, 2013, a prehearing conference was held to schedule the remanded hearing. The Commission postponed the Na Wai Eha contested case hearing until further notice to allow the parties to meet and discuss potential avenues of settlement. On April 17, 2014 the Commission approved and adopted the Hearings Officer's Recommendation on the Mediated Agreement Between the Parties and the Stipulation Re Mediator's Report of Joint Proposed Findings of Fact, Conclusions of Law, Decision and Order.
- CCH-HI11-1** - Weight/Henderson/Jung/Okazaki, Contested Case Hearing for After-the-Fact Stream Channel Alteration Permit (SCAP), Stream Diversion Works Permit (SDWP) and Petition to Amend Interim Instream Flow Standard (PAIFS) for Ainako Branch Stream; and Complaint/Dispute Resolution for Ainako Branch Stream. The contested case hearing was held on February 29, 2012 and March 1, 2012 in Hilo, at 9:00 a.m. at the State Office Building Conference Rooms, 75 Aupuni Street. The Hearings Officer issued his Proposed Findings of Fact, Conclusions of Law and Decision and Order on June 5, 2012. The Parties filed written exceptions to the Proposed Findings of Fact, Conclusions of Law and Decision and Order on Friday, June 22, 2012. Oral Argument on exceptions to the Proposed Order was held on September 19, 2012. The Commission's Findings of Fact, Conclusions of Law, and Decision and Order was issued on January 23, 2013. Currently on Appeal to the Intermediate Court of Appeals.
- CCH-MA13-01** - Petition to Amend Interim Instream Flow Standards for Honopou, Huulo (Puulua), Hanehoi, Waikamoi, Alo, Wahinepee, Puonokamoa, Haipuaena, Punalau/Kolea, Honomanu, Nuaailua, Pinaau, Palauhulu, Ohia (Waijanu), Waioakamilo, Kualani, Wailuanui, West Wailuaiki, East Wailuaiki, Kopilulu, Puakaa, Waiohau, Paakea, Waiakaa, Kapaula, Hanawi, and Makapipi Streams.
- CCH-MA13-02** - Provisional Recognition of Appurtenant Rights, Na Wai Eha Surface Water Management Area, Waihee, Waiehu, Iao, Waikapu Streams, Maui, Hawaii. On December 13, 2014, the Commission issued a Na Wai Eha Provisional Order On Claims that Particular Parcels Have Appurtenant Rights. - CCH-MA15-01** - Surface Water Use Permit Applications, Na Wai Eha Surface Water Management Area, Waihee, Waiehu, Iao, Waikapu Streams, Maui, Hawaii. On January 28, 2015, the Commission determined that a contested case hearing is required to hear and determine all surface water use permits applications in the Na Wai Eha Surface Water Management Areas, Maui, and delegated authority to the Chairperson to appoint a Hearings Officer.
