#### A. New Notices/Announcements

##### Pearl Harbor Water Shortage Plan Adopted by the Commission on Water Resource Management

The Commission on Water Resource Management unanimously voted to adopt the Pearl Harbor Water Shortage plan at its August 18, 2020 meeting. Water use permit holders in Pearl Harbor will be subject to the conditions in the plan should a water shortage be declared in Pearl Harbor by the Commission.

##### County Drought Committee Meetings


Commission staff convened four county drought committee meetings in June to hear about current and expected drought conditions in the upcoming dry season. These committees also heard about drought impacts from stakeholders and any drought preparedness, mitigation and response actions planned or being taken.


We are currently in ENSO-neutral conditions (neither El Niño nor La Niña) and there is a chance that La Niña may develop in the fall/winter of 2020. At the beginning of June the expectation was that drought conditions would worsen and expand in the islands' dry leeward areas throughout the summer months. Widespread impacts will be to surface water supplies, unirrigated agriculture/pasture, and increased risk to wildland fire. USDA designated Hawai'i County as a primary disaster area due to drought ([https://www.fsa.usda.gov/news-room/emergency-designations/2021/ed\\_2021\\_0706\\_rel\\_0099](https://www.fsa.usda.gov/news-room/emergency-designations/2021/ed_2021_0706_rel_0099)).

## C. Petitions for Reservation of Water

- **Res - OA93-1** - The State Department of Agriculture (DOA) filed an incomplete petition for reservation of 47.60 mgd of water flowing in Waiāhole Ditch for agricultural uses on lands in Central and Windward O'ahu.
  - **Res - OA94-2** - The Office of Hawaiian Affairs' Committee on Land and Sovereignty has filed an incomplete petition to reserve 11 mgd of water from the Waiāhole Ditch for present and future Hawaiian uses in the Waiāhole area.
  - **Res - OA94-3** - The Kahalu'u Neighborhood Board, Waiāhole Waikāne Community Association and the Hakipu'u 'Ohana have filed an incomplete petition for the reservation of all of the water from the Waiāhole Ditch that is developed on the Windward side of O'ahu, for agricultural uses.
  - **Res - OA94-4** - The Kamehameha Schools/Bernice Pauahi Bishop Estate has filed an incomplete petition to reserve all of the waters originating from the ahupua'a of Waiawa (estimated to be 4.2 mgd) that flow in the Waiāhole Ditch. The stated purpose is to serve future development on seven parcels of land in the Waiawa area.
  - **Res - OA95-1** - The State Department of Hawaiian Home Lands has filed an incomplete petition to reserve an estimated 410,000 gallons per day of water from Waiāhole Stream to serve its beneficiaries on five parcels of land (some 82 acres) in Waiāhole.
  - **Res - OA95-2** - The State Division of State Parks has filed a water reservation of an estimated 0.125 mgd of water from Kahana Stream to serve agricultural programs and residential lessees' subsistence agricultural permits in Kahana Valley State Park. This reservation is not presently part of the Waiāhole Ditch combined contested case.
  - **Res - 563 (Res - OA97-2)** - The State Department of Hawaiian Home Lands has filed an incomplete petition to reserve an additional 2.303 mgd of groundwater from the Waipahu-Waiawa Aquifer System for foreseeable needs in the Wai'anae, 'Ewa, Honolulu, and Ko'olaupoko Districts.
  - **Res - 1099** - The State Department of Hawaiian Home Lands has filed an incomplete petition to reserve 0.855 mgd of groundwater from the 'Ualapu'e Aquifer System for foreseeable needs in the 'Ualapu'e area, Moloka'i.

## E. Contested Case Hearings Pending at the Commission:

- **CCH-MA15-01** – Surface Water Use Permit Applications, Nā Wai 'Ehā Surface Water Management Area, Waihe'e, Waiehu, 'Āao, Waikapū Streams, Maui, Hawaii'. On January 28, 2015, the Commission determined that a contested case hearing is required to hear and determine all surface water use permits applications in the Nā Wai 'Ehā Surface Water Management Areas, Maui, and delegated authority to the Chairperson to appoint a Hearings Officer. The Hearings Officer issued his Proposed Findings of Fact, Conclusions of Law and Decision and Order on November 1, 2017. The Commission issued its Findings of Fact, Conclusions of Law, and Decision and Order on June 28, 2021, along with an Executive Summary. On June 30, 2021, the Commission issued an Errata to the Findings of Fact, Conclusions of Law, and Decision and Order. Due to the large number of surface water use permits to be issued, Section K, Surface Water Use Permit Applications and Objection Deadlines, will be updated in a future Water Resource Bulletin.
- **CCH-KA19-01** – On March 19, 2019, the Commission granted the petitions for a contested case hearing filed by Ho'opulapula Nā Wai O Puna and

James Torio, and consolidated into one hearing. The petitions filed by Kaua'i Island Utility Cooperative, Department of Hawaiian Home Lands, and Grove Farm were denied; however, the petitions will be referred to the hearings officer for consideration in a manner consistent with all other requests for party status and compliant with applicable rules. The Commission has also delegated authority to the Chairperson to hire and appoint a Mediator to mediate the dispute regarding the interim instream flow standards of Wai'ale'ale and Waikoko Streams, after the parties to the contested case hearing have been determined.

- **CCH-MA20-01** – On June 16, 2020, the Commission granted a petition for a contested case hearing filed by Wailuku Water Company, LLC to enter into a contested case hearing on the Issuance of Written Notice of Violation for Enforcement Against Waste, and Recommendation to Impose Fines Against Wailuku Water Company, LLC, Owner/Operator of Waihe'e Ditch, in Response to HRS §174C-13, Citizen Complaint filed by Hui o Nā Wai 'Ehā Alleging Waste by Wailuku Water Company at Pale'a'ahu Gulch, Nā Wai 'Ehā Surface Water Management Area, Maui, TMK No. (2) 3-6-004:003.
  - **CCH-OA20-02** – On October 20, 2020, the Commission granted petitions for a contested case hearing filed by John and Linda Hayama, Structural Hawai'i, Inc., and HH Constructions Inc. to enter into a contested case hearing on Request Imposing a Fine Against the Applicant - Structural Hawaii, Inc., Landowner - John and Linda Hayama, and Contractor - HH Constructions Inc., for Altering a Stream Channel Without a Permit as Required in HRS §174C-71(3)(A) and HAR §13-169-50 For the Installation of a Gabion Retaining Wall, Hayama Residence, Mānoa Stream, Mānoa, O'ahu, TMK: (1) 2-9-037:085. On April 1, 2021, the Commission issued an Order Approving Proposed Settlement Agreement with the Hayamas and HH Constructions in the amount of \$12,000. On June 9, 2021, the Commission issued an Order Dismissing Enforcement Action Against Structural Hawaii, Inc.
  - **CCH-MO20-03** – On October 20, 2020, the Commission granted petitions for contested case hearings from Ahonui Homestead Association, Department of Hawaiian Home Lands, and Mahina Poepoe representing Kūpeke Ahupua'a to enter into contested case for GWUPA 1094 for the Maui Department of Water Supply (MDWS) for increased withdrawals from ground water from the 'Ualapu'e Aquifer System Area. On February 10, 2021, MDWS submitted a letter to the Commission withdrawing GWUPA 1094 and stated that it would limit its pumping at 'Ualapu'e Shaft to its previously permitted amount.
  - **CCH-OA20-04** – On November 17, 2020, the Commission granted a petition for contested case hearing from Protect Mokulē'ia Hui to enter into contested case for GWUPA 1088 for Dillingham Ranch for modified withdrawals of ground water from the Mokulē'ia Aquifer System Area.
