Approval of Chairperson's Appointment of Jeffrey T. Pearson, P.E., as First Deputy to the Chairperson of the Commission on Water Resource Management

In accordance with Section 174C-6, Hawaii Revised Statute, I am hereby submitting for your approval, my appointment of Mr. Jeffrey T. Pearson to the position of First Deputy for the Commission on Water Resource Management with the Governor's concurrence (Exhibit 1). He will begin working as Deputy as of August 25, 2015 subject to your approval.

HRS §174C-6(a) states, in relevant part, "The deputy shall have experience in the area of water resources and shall be appointed by the chairperson with the approval of a majority of the commission." HAR §13-167-8(a) contains an identical provision. Exhibit 2 provides Mr. Pearson's background that shows Mr. Pearson is a licensed professional engineer with extensive experience and commitment in the area of civil/environmental engineering. His experience with the Maui Department of Water Supply and private water systems provides excellent qualifications for the job of representing and supporting the Commission on Water Resource Management and its staff in protecting and managing the precious water resources of Hawaii.

Exhibit 3 provides written testimony submitted on this appointment at the time of this submittal's drafting. All testimonies have been in support of confirmation.

## **RECOMMENDATION:**

That the Commission approves the appointment of Mr. Jeffrey T. Pearson, P.E. to the position of Deputy to the Commission on Water Resource Management effective as of August 25, 2015.

Ms.Case:

I have been working in the development of wells and water systems throughout the State of Hawaii for the last 43 years, including substantial work on Maui. I first interacted with Jeff Pearson when he was Deputy Manager of the County Department of Water Supply, subsequently when he was employed by Maui Land and Pineapple Company and was running the Kapalua Water Systems (potable and non-potable, the latter supplied by the Honokohau Ditch), and currently in his role back with the Department of Water Supply. Based on this experience over a number of years, I have no reservations in recommending Jeff for the Deputy Director position with the Water Commission. Two attributes of his particularly stand out. First, he has excellent people skills. He gets along with a wide range of individuals in a calm and professional manner - skills often needed by the Deputy in dealing with contentious issues the Water Commission often faces.
