MINUTES:

Mr. Apaka moved that the minutes of September 28, 1990 be approved as circulated. Seconded by Ms. Himeno, motion carried.

ADDED

ITEM:

Item E-3 Request to Erect Model Shelter on the State Capitol Grounds

Items on the agenda were considered in the following order to accommodate those applicants and interested parties present at the meeting.

APPROVAL OF GRANT-IN-AID FOR HUI O LAKA, KAUAI ITEM E-1

Mr. Nagata informed the board that Hui O Laka, through a State lease is responsible for the maintenance and administration of the Kokee Natural History Museum. He said that staff was recommending that the Board authorize the Chairperson and another member to enter into a grant-in-aid contract.

Mr. Nagata said that he would like to point out a couple of things for the Board's information which occurred since the submittal was prepared. He understands that the Department of Education is also trying to push through the legislature for an interpretative type of facility for school children. It is as yet unfunded and would cater to the school kids.

This particular training center could also cater to school children but also to visitors and the scientific community.

Mr. Nagata said he wanted to point out that State Parks had a concern with the location and of the site that is being proposed. Staff has been in touch with Hui O Laka because the same site is also being proposed as the sewage treatment plant (STP) and leach field as needed to service the museum, the Kokee Lodge and the nearby cabins.

The Hui O Laka people have looked at several different alternatives and they favor an alternative elsewhere for the sewage treatment plant and leach field system. They are not sure that they will be able to construct in that area, so whatever they are recommending is subject to determining the location of the site.

Staff wants the Board to know that should they approve this submittal they are not approving the site.

Mr. Nagata said they'd like to take a closer look at the determination of the site and they think the department should determine where the site should be. The department is already designing for the very same site for the sewage treatment plant. They feel that the department, division together with the Chairperson can make the decision to inform Hui O Laka whether the site is not available once they have a chance to fully look at the letter that was submitted in their proposal.

Mr. Arisumi's question to Mr. Nagata was whether they would come back to the Board if the site was not available and a new site selected.

Mr. Nagata replied that was not necessarily so unless the Board wishes.

Mr. Arisumi felt that it is the responsibility of the Board and the matter should be brought back to the Board for approval once the site is set.

Ms. Marsha Erickson, Executive Director of Hui O Laka tried to show a video of the proposed project area, but the VCR was not working properly. Because there were problems with the VCR she said she would try to paint a picture for the Board members as it's impossible for all the members to visit the site because it's so far away.

She wanted to make it clear that as far as Hui O Laka is concerned, there is no dispute or problem with the Division of State Parks. They acknowledge the need for a sewage treatment plant at Kokee. The one thing that she wanted to point out is the site that has been chosen. The site assessment survey done by Belt Collins was picked before this proposal was an active proposal. This became an active proposal when they actually got permission to renovate one building. Referring to the proposal in the copies she passed out this morning, the site plan, building (1) is completely renovated. These buildings are 1930's wooden buildings and they are deemed structurally sound and they had no trouble renovating that. They have not yet moved in and there's no electricity in the building.

The siting for the leach field is in the middle of the quadrangle area and would necessitate the removal of buildings (4), (5) and (6), and then the attendent smell would definitely affect the rest of the site as the technology is not perfected with leach fields, . We're proposing that we take the old C. C. C. Camp and renovate them, approximately 9,000 square feet of usable space at Kokee for this use. It is a proposal that the entire Department of Land and Natural Resources could make us of. In addition, other agencies have expressed desire for occasional use; researchers at the UH, Manoa and the Pacific Tropical Botanical Gardens are just a few to mention. The museum is non-profit working with State Parks and under contract with DLNR though there's no exchange of money.

The reasons for this project is (1) Joe Souza was the founder of Kokee Museum as well as the chief architect of State Parks in its early years; (2) the functional reason is that we're mandated to create interpretation for Waimea Canyon and Kokee State Parks.

Even though State Parks has gone through the design stage she asked that the Board take a look at the long term solution and also be able to use the old C.C.C. camp site for this innovative use.

In closing she said that they're actually interested in recycling that site because it exists, because they don't have to bulldoze any brand new forest for it. If that site were destroyed, she supposes they would put this proposal on a major back-burner because they do not believe that the Division of State Parks or the State government is going to be able to reproduce 9,000 square feet of usable space for a wilderness park. It's there now, they can use it and it is eminently repairable. This is a little background on the project and she appreciates the division's recommendation that they be allowed to perceive with this initial phase.

Mr. Arisumi addressed Nr. Nagata to arrange a field trip so that the Board could view the site first hand.

Mr. Yuen's question to Mr. Nagata was, "If you put the STP by the C. C. C. camp with the leach field in the quadrangle, does that pretty much make that camp, unusable, the old camp?"

Mr. Nagata replied, "Yes, my understanding is as she mentioned, it would require taking down some of the buildings."

Another question by Mr. Yuen was, "Isn't there somewhere away from all these buildings that you can locate a 15,000 square foot leach field? It seems that you have all these buildings up there, to put it next to all these buildings when all you need is an open area to run some pipes and let the water flow in the ground. It seems there must be some place."

Mr. Nagata replied, "It also deals or has to do with the soil condition. As I indicated, with some of the comments that have been made in the submittal and proposals, we'd be willing to have the consultant take another look at it and if there is some reasonable alternative we'd be happy to consider it, but I want to make sure that the Board in its deliberation today did not take for granted that this was the location. This was my main purpose of making the comment."

ACTION Unanimously approved as submitted. (Apaka/Himeno)

REQUEST TO ALLOW CAMPING FOR SOLAR ECLIPSE VIEWERS AT THE OLD KONA 1TEM E-2 AIRPORT AND HAPUNA BEACH STATE RECREATION AREA

Mr. Nagata said their division was approached by many people to allow camping for viewers of a solar eclipse which will occur on July 11, 1991. The center of the eclipse will pass through Hilo and continue across the center of the island to West Hawaii making the island of Hawaii the premium site to view this phenomena.

Staff's recommendation is that the Board designate Hapuna Beach and Old Kona Airport State Recreation Areas for camping the evening of July 10, 1991 and ending the morning of July 11, 1991 to accommodate the solar eclipse viewers and to waive issuance of permits.

Discussion followed on available manpower to take care of parking, pitching up tarps next to the cars, toilet facilities and other anticipated problems. The estimated number of cars for Old Kona Airport is 600 cars and estimate for Hapuna is about 300 cars.

ACTION Unanimously approved as submitted. (Yuen/Apaka)

ITEM E-3 REQUEST TO ERECT MODEL SHELTER ON THE STATE CAPITOL GROUNDS

Mr. Nagata made the presentation of Representative Reb Bellinger's request to erect a model shelter structure on the State capitol grounds.

Discussion followed that should the Board allow this model shelter structure to be erected on the State capitol grounds, it may open the door for others to apply to erect their products also.

Staff's recommendation was to deny the request.

ACTION Motion was made by Ms. Himeno to approve Item E-3 as submitted, which was to deny the request. Seconded by Mr. Apaka, motion carried.

Mr. Young presented a map to the board and pointed out the areas of interest. He mentioned that staff worked with the Attorney General's Office in trying to straighten out the boundaries.

If staff wants to amend the lease for land exchange, they can only exchange it for equal area affecting the lease because it was sold at public auction, this was on the advice received from the Attorney General's Office. An appraisal will also have to be done to be sure the area is of equal square footage and same zoning.

Reason for two proposed land exchanges is because part of the land in question is not affected by the lease. This land exchange is needed to straighten out the boundaries.
