Mrs. Mary Richards explained the problems they had with the parking for visitors and for people coming for classes at the summer palace. She also mentioned that they needed the time to raise the necessary funds. They are comfortable with all the conditions.

VARIATIONS TO APPROVED CONSTRUCTION PLANS FOR CDUA MA-733 FOR SINGLE FAMILY RESIDENTIAL USE AT MAKENA, MAUI, HAWAII, TAX MAP KEY 2-1-6:16, APPLICANT: MS. JUDITH CARLSBERG; AGENT: MR. B. MARTIN LUNA

Mr. Roger Evans explained that the applicant did not build according to the plans submitted. Because of the violation for lack of compliance, staff was recommending a fine of \$500.00. Staff is also recommending approval of the plan as-built.

Discussion followed regarding staff follow-up on approved applications and building plans. It was explained that 5 years ago the department did not have the resources to follow-up closely. Currently, the division has incorporated with the Division of Conservation and Resource Enforcement whereby, as a part of their daily rounds on all islands, they are aware of what the Board has approved and they check what the Board has approved on a general land use and submit a report whether it's in compliance or not.

It was pointed out that the applicant was the person that brought the changes to staff's attention. The applicant came forward and let the Board know that plans were different. Based on the original plans, the changes were reasonable and basically conform to their original plans. It was suggested that the fine be reduced or maybe eliminated. Originally, there was no condition placed on the applicant regarding landscaping.

ACTION Mr. Arisumi moved for approval and that the fine be reduced to \$200.00. Seconded by Ms. Himeno, motion carried.

Mr. Evans presented Item H-8 with staff's recommendation for approval subject to the 13 conditions listed in the submittal. He mentioned that the application was

sent out to different agencies for review and received no objections. This effort was also coordinated with the Department of Budget and Finance.

Ms. Mary Cummins, agent, said that the proposed electrical poles and lines are a continuation of the original existing CDUA that was approved for the Department of Budget and Finance to provide electrical service to the applicable site. B & F is proposing to combine their facility with Motorola's facility to have a co-habitation situation where they would be reducing the overall effect on the environment by eliminating one tower although requesting to increase the height of the Motorola Tower by 40 feet to accommodate their antenna and additional dishes. This will allow the State to implement their program for their inter-island telecommunications as well as to provide a base for the State Civil Defense, the police department and the fire department.

Mr. Bob Matsumura of the Department of Budget and Finance, Information and Communication Services Division (ICSD) spoke in support of this co-habitation. They are one of the tenants that will be sharing the site and their program is to provide the State with communication for voice data and video. Also, part of their program includes the HITS program which is part of the Hawaii Public Television Authority and this is for the educational program.

REVIEW OF PETITION FOR RECONSIDERATION AND AMENDMENT OF CDUA FOR PROPERTY CONSOLIDATION AND RESUBDIVISION, MANOA, OAHU; TAX MAP KEYS 2-9-33:24 AND 2-9-34:15, APPLICANT: MR. AND MRS. GREGORY REESER; AGENT MR. RONALD V. GRANT, DWYER, IMANAKA AND SCHRAFF

Mr. Evans brought the Board up-to-date regarding this piece of property. A request was made for a Contested Case hearing and that request was taken under advisement. The recommendation to the Board is that the request for the Contested Case hearing be denied. Should the Board deny this request, staff is asking that the Board reaffirm on page 4, under B. Violation and C. Land Use.

The property has since been sold and there is a new landowner. The conditions now go with the new landowner. Discussion followed.

Mr. Dean Yamamoto, representing the applicant said that Mr. Reeser sold the house sometime in April. Mr. Reeser and the new landowner are trying to work out whose obligation it is to address these conditions. He then requested of the Board that this matter be continued at the next meeting of the Board to give Mr. Reeser and the new landowner an opportunity to decide who will comply with these conditions.

Mr. Yamamoto said that Mr. Reeser has indicated to them in a letter that he will comply with all the conditions, file the appropriate plans and pay the appropriate fines and administrative costs, however the new landowner wants more assurances of Mr. Reeser's verbal words.

During the discussion it was asked if the Board could act on part A. and defer B. and C. to the next meeting. There was no objection on staff's part.

Dr. Barry Nutter, the new landowner said that he purchased this property with one week's notice that there was a disagreement with the boundary line. At the time of closing, he was informed that the variance had been allowed and that everything was done and there would be no further discussion on the matter. He was presented with a submittal that the Board had met, there was a variance allowed and that was it. Afterwards, he understood that there was a reason for the decision to be held in abeyance because of the complaint. He assured the Board that he is making every effort to work with Mr. Reeser regarding his fines to be paid. If there is a problem with the fines being met and the condition being met, he assured the Board that he would take care of that personally.

Dr. Nutter said that his recommendation is that the Board act on this today as he feels confident with Mr. Reeser's attorney and his telephone conversation with Mr. Reeser that he'll be able to work that out with him.

Mr. Yamamoto then said, "Given Dr. Nutter's decision to go ahead, I wish to withdraw my request for continuance of this Board."

Chairperson Paty so noted.

Mr. Evans requested a change of wording on page 2 under RECOMMENDATION: "That the Board approve a time extension of one year under Title 13. Chapter 1, Section 14 to complete construction of the project, subject to the following conditions:". He explained that this was not under the CDUA rules but under Rules of Practice and Procedure that govern the whole department. Under those rules it specifically states that upon application, permit the act to be done after the expiration of a period. Staff would like to modify its recommendation to allow it under that rule.

Mr. Evans explained that there was a funding problem relative to design and construction of the diesal underground tanks.

Mr. Bob Matsumura of the Department of Budget and Finance, ICSD, explained that they are trying to install the diesel tanks as back-up fuel for a back-up generator for their microwave equipment. This equipment is needed for transmission from Honolulu through Maui and to Hawaii in case of an emergency. Originally they had planned to have diesel back-up generation but they have not completed that portion of the construction.

Mr. Dana Chun, representing King Food Service clarified that the figures on page 4, item 4 regarding major stockholders should be (40%, 10%, 25%, 25%).

Mr. Evans said that the applicant owns land in Santa Cruz, California and there was an earthquake there recently. Their business was disrupted by the earthquake also.

There has been a redesign of the house and they have also been in consultation with the National Tropical Botanical Gardens which is across the street from this property in Haena. Relative to the original conditions place upon this application, the applicant has expended an amount of \$25,000 to carryout some of the required studies. Staff feels that their intent is sincere, reasonable and in good faith. Staff is recommending approval of the extension and again under Title 13, Chapter 1, Section 14.

Mr. Walton Hong, representing the applicant, said that they will be applying for a County Building Permit as one of the CDUA conditions. They will comply with all State and County building codes. Mr. Hong said that the recommendation is to extend the completion date to April 23, 1993, but in view of the hurricane, he does not know what delays they will be facing in getting permit approvals. He mentioned that they might have to be come back for another extension.
