ITEM D-5: DIRECT GRANT OF EASEMENT TO HAWAII ELECTRIC LIGHT CO., INC. FOR ELECTRICAL TRANSMISSION LINE PURPOSES, KEHENA AND KEEKEE, PUNA, HAWAII, TMK: 1-2-09:POR.3

Mr. Yuen disclosed for the record that this proposal would bring electricity to, among other areas, the Kehena Estate Subdivision in which his uncle was one of the two original codevelopers about 30 or 40 years ago of which his immediate family doesn't have an interest in. Second, Mr. Yuen has been legal counsel for the Kalapana Seaview Estates Community Association ("KSECA") for about four (4) years, and this proposal would also bring electricity to that subdivision. To the best his knowledge, information, and belief, KSECA hasn't taken an official position for or against this proposal. These disclosures were discussed with the attorney general's office and with that being the extent of Mr. Yuen's involvement with HELCO, it was determined there isn't any conflict-of-interest.

Mr. Matsumoto stated for the record that due to his law firm's affiliation with HELCO, he recuses himself from voting on any action.

Dean Uchida presented the staff recommendation to the board. The following individuals testified:

Colette Sakoda provided the board with technical information on the proposal.

Athena Peanut, on behalf of Friends of the Red Road, voiced objection to the proposal and feels the board would be basing its decision on a faulty and inadequate final environmental impact statement which is currently being challenged in Third Circuit Court. She requested that this issue be evaluated in its entirety, and that any future public hearings be held on the Big Island in order to prevent financial hardship for residents who would like to testify on the matter.

Emily Naeole, as a native Hawaiian, testified against approval of this project.

Carlyle Knutson, retired property owner, expressed his desire and right to have power in his subdivision and stated that in the last five (5) years he's been there, he has never seen any of the endangered birds referred to earlier.

Elizabeth Olsen, property owner, testified in support of HELCO's project.

Property owner Greg Bitner, on behalf of fifteen (15) lot owners, testified in support of HELCO's project.

Henry Curtis, Life of the Land, testified that a public hearing on this matter should be held on the Big Island so the residents can voice their concerns before any decision is made on the matter.

Janet Lesher (sic) testified in support of the HELCO project.

RECOMMENDATION:

That the Board:

A.2. HELCO, its successors, permitted assigns, or permitted devisees, shall maintain and repair all structures and other improvements constructed, built, and/or erected thereon at no cost or expense to the State of Hawaii, nor to the County of Hawaii, including periods of emergency.

- A.10. HELCO, its successors, permitted assigns, or permitted devisees, shall submit construction plans for approval by the Chairperson prior to the commencement of any construction work activity.
- B.4. HELCO, its consultants and/or its contractors, shall submit construction plans for approval by the Chairperson prior to the commencement of any construction work activity.

Subsequent to board action, Steven Lee Montgomery, Ph.D., submitted written testimony requesting that an EIS be completed before any action is taken; however, the board already rendered its decision.
