MINUTES:

December 15, 1995

ACTION: Deferred to next regularly scheduled board meeting in order to provide additional review time for board members (Yuen/Kennison).

All written testimonies and other relevant documentation submitted herein are available for public inspection and/or review at the Chairperson's Office of the Department of Land and Natural Resources. Cassette tape recordings of the instant proceedings are available for review and/or may be duplicated upon request.

ITEM D-20: REQUEST TO AMEND CDUP OA-1947A, GOLF COURSE AT KOOLAUPOKO, OAHU, TMK: 4-5-42:1 AND 6

Dean Uchida presented the staff recommendation to the board.

A motion was made to go into executive session in order to consult with counsel on the legal issues raised at the prior board meeting (Yuen/Nekoba). Mr. Apaka called a recess at approximately 9:50 a.m. Chairperson Michael D. Wilson reconvened the meeting at approximately 10:30 a.m.

Deputy Attorney General Linnel Nishioka stated for the record:

"Counsel for Long Term Credit Bank ("LTCB") has confirmed orally and in writing that LTCB acknowledges that the Board of Land and Natural Resources played no role in the negotiation in the Stipulation for Conditional Settlement of Claims Against Defendant The Minami Community Foundation, and that the Board's approval of the Stipulation shall in no way be construed as a concession of admission by the Board or the State of Hawaii that the CDUP, or any of the conditions thereto, including the conditions challenged by LTCB in its foreclosure action, LTCB v. Minami, et al., Civil No. 94-4508-11 (First Circuit), are invalid or unconstitutional. In reliance upon these representations and the representations made in the letter dated April 11, 1996, from counsel for LTCB to myself, I recommend that the Board approve Item D-20, as amended, which in essence is requesting approval of the Staff's recommendation as set forth on Page 4 of the March 22, 1996, board submittal Item D-19."

Subsequently, a second motion was made to direct staff to check whether the area in the resource subzone on this property should be downzoned into the protective or limited subzones based on its resource value; and that as a part of its on-going Conservation District Review Project, staff should assess whether the area in resource subzone is appropriate for a higher level of protection through the rezoning process (Yuen/Apaka).

The board expressed concern about potential problems the goats may cause should they escape.

Albert H. Silva, Permittee, appeared before the board and testified that domesticated goats aren't likely to run away from the herd and tend to stay near food which he would provide in an identified area. In addition, he didn't want the goats to be running all over the hillside since it would be difficult for him to get at. Moreover, if the area is used for goats, it would probably be the lower part of the property where there's sufficient vegetation to support the herd, and the area would probably be kept small and enclosed to keep the goats in a defined area.

Prior to any use of the property by the Permittee, the Permittee is required to 12. work with DOFAW on developing a "Management Plan" for the grazing use of the area. This plan must be approved by DOFAW and would include, but not be limited to, the following: number and type(s) of animals, fencing, water requirements, location of animals on the property, length of grazing time, etc.
