Dean Uchida presented the staff recommendation to the board.

The following individuals testified before the board:

Mr. Peter Schall, Managing Director, Hilton Resorts, Applicant, testified in support of the proposed project and responded to questions asked by the board.

Mr. Richard Heaton, President of The Enterocean Group, Applicant, testified in support of the proposed project and responded to questions asked by the board.

Mr. Eric B. Guinther, AECOS, Inc., Consultant, testified in support of the proposed project and responded to questions asked by the board.

Ms. LaVonne West, Hilton Resorts resident for 22 years, stated her concerns with the project, but was agreeable to the notion proposed by Chairperson Wilson to have DLNR's Community Services Coordinator, Athline Clark, work with Mr. Schall to provide the public with programs promoting educational use of the facilities.

Mr. David Dodge, President of the Waikiki Improvement Association, testified in support of the Hilton Lagoon Project. This project has received favorable comments by the Waikiki community. The chance to improve the water quality of the lagoon and the Ala Wai Boat Harbor through an improved flushing system is welcome, and such improvements will increase Waikiki's competitiveness as a first-class resort destination.

Mrs. Elizabeth Corbin, Department of Business, Economic Development, and Tourism Representative, testified in favor of the facility and its construction. Not only will this project add to tourism diversification, it will provide a new destination and type of experience for Hawai'i's repeat visitor, help to disperse use away from some of Hawai'i's most heavily used natural resource areas, such as Hana'uma Bay, while enhancing the resource in which the project is to be built. Enhancement of the lagoon will provide greater enjoyment for both residents and visitors. Tourism is expected to remain the backbone of the Hawaiian economy, and this project will greatly add to these revenues. This project is environmentally sound, socially sensitive, and economically beneficial.

Ms. Barbara Okamoto, on behalf of Paul J. Casey, President and CEO of the Hawai'i Visitors and Convention Bureau, testified in support of the project. In addition to improving the quality of the lagoon, this project will help maintain and further enhance the visitor industry which provides an estimated \$1.79 billion in tax revenue to our state.

Mr. Art Challacombe, representing Cheryl Soon, Planning Director for the City's Department of Land Utilization, testified in support of the project. It can provide education and entertainment opportunities for students, visitors, and the community and will enhance the area; improve water quality of the lagoon and surrounding marina by providing a constant flow of cleaner seawater, a second discharge system enhancing the water quality of the public portion of the lagoon and the Ala Wai Boat Harbor; remove nuisance jellyfish and high coliform/enterococcus counts; improve beach conditions in the area; maintain uninterrupted view planes; foster a Hawaiian sense of place for Waikiki; and serve an economic purpose by providing employment for an additional 80 to 120 persons. We are satisfied that parking requirements will be met for school/tour buses and visitors. Noise pollution will be kept to a minimum as reservations are required and all preparation procedures are handled indoors.

Ms. Janet Clark testified in further support of the project.

**ACTION:** 

Approved as amended (Kennison/McCrory). Amendment: Add Condition 29 to staff recommendation as follows:

29. The Applicants work with the Department on a program for providing the public educational use of the facilities.

Due to the Board's inability to maintain a quorum, Member Kennison made a motion to defer all remaining agenda items to the next scheduled board meeting. Member McCrory seconded the motion. Approval of the November 8, 1996 Minutes and all remaining agenda items are deferred to the next scheduled land board meeting.
