The Board of Land & Natural Resources approved the award of the construction contract for the subject project on July 8, 2011. Pursuant to Chapter 343, Hawaii Revised Statutes (HRS), and Chapter 11-200, Hawaii Administrative Rules (HAR), the attached Exemption Notification labeled Exhibit A was prepared.


The project consists of clearing and grubbing, cold planing, placing aggregate base course, pavement resurfacing, and installing striping and pavement markings.

In accordance with Hawaii Administrative Rule Section 11-200-8(A) and the Exemption List for the Department of Land and Natural Resources, Division of State Parks, as reviewed and concurred upon by the Environmental Council on December 4, 1991, the subject project is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, Item No. 2 that states "Roads, road structures, roadways and trails – within developed, maintained portions of State Parks [February 5, 1976].

RECOMMENDATION:

Declare that, after considering the potential effects of the proposed project as provided by Chapter 343, HRS, and Chapter 11-200, HAR, these projects will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
