

Note that both of their businesses were advertised on the same flyer. AQUINO's business name is "Big Island Canoes". For further information on the flyer, refer to the Property and Evidence receipt that was submitted by Officer GUITERREZ under master report HA 14-249.

It is recommended that all permits issued to both AQUINO and BONAFEDE be either suspended or revoked and no other permits be given to them. I also recommend a high fine be issued.


DISPOSITION


In view of the above information and the information in the master report, I recommend that this case be closed for record purposes and a copy of this report be routed to Land Board for their action.
