Request Approval to Initiate Rule-Making Proceedings to Amend Hawaii Administrative Rule, Chapter 13, Section 13-233-26, Charges for Parking

REMARKS:

The Division of Boating and Ocean Recreation (DOBOR) amended and compiled Chapter 13-233 on April 05, 2008 as they pertained to motor vehicle operations in the state small boat harbors. As part of the rule amendment package, Hawaii Administrative Rule (HAR), Section 12-233-26, was amended to state that parking rates would be set at equal to or less than County rates.

DOBOR is in the process of implementing a parking plan at the Maalaea small boat harbor, Maui. It came to DOBOR's attention that the County of Maui does not charge for public parking. The paid parking is through the Department of Accounting and General Services for various state facilities.

DOBOR proposes to amend Section 13-233-26 so the parking fee can be set at equal to or less than State or County rates (see Exhibit A). This will enable the department to establish parking fees in areas where the Counties do not charge for public parking.

RECOMMENDATION:

1. Grant to the Division of Boating and Ocean Recreation approval for the initiation of rule-making proceedings to amend Chapter 13-233, Section 13-233-26, HAR.

EXHIBIT A

§13-233-26 Charges for parking. Charges will be made and collected for parking, stopping, or standing a vehicle in paid parking zones equal to or less than county or state rates in the county where the paid parking zone is located. [Eff 2/24/94; am and comp 4/5/08; am and comp _____] (Auth: HRS §§200-2, 200-4) (Imp: HRS §§200-2, 200-4)

2. Material, except source notes, to be repealed is bracketed and stricken. New material is underscored.


3. Additions to update source notes to reflect these amendments are not underscored.
