Lot 75, Kōke'e Campsites Lots, Waimea (Kona), Kaua'i, Tax Map Key: (4)1-4-004:069, as shown on the attached legal description and survey map labeled Exhibit A.

.56 acres, more or less.

CHARACTER OF USE:

Recreation - residence.

TERM OF LEASE:

Twenty (20) years, commencing January 1, 2009, and expiring on December 31, 2029.  
There is one rental reopening scheduled after ten years.

ANNUAL RENTAL:

\$7,000.00.

CONSIDERATION:

No valuable consideration or money.

RECOMMENDED PREMIUM:

\$0.00.

DCCA VERIFICATION:

Not required. Applicant is not required to register with DCCA.

APPLICANT REQUIREMENTS:

Applicant/Assignee shall prepare and submit fully executed assignment of lease and meet other requirements as described herein.

REMARKS:

Kelly Carswell-Haneberg and David Carswell acquired their interest in the lease by assignment from the original lessees, Curtis and Bonnie Lofstedt and the Georgia Poppin Trust (Original Lessees)<sup>1</sup> who entered in to the lease cited above effective January 6, 2009 as a result of direct negotiations with the Department of Land and Natural Resources (DLNR) pursuant to Act 223 SLH 2008. Original Lessees held the previous lease covering the property.

Lessee is in compliance with the lease terms and conditions.

Staff notes that the term of the lease is for a period of 20 years commencing January 1, 2009. On the first page of the lease, however, the termination date is listed as December 31, 2029 in error. This would indicate a 21 year lease and is inconsistent with Act 223. Upon consultation with the Department of the Attorney General, a simple amendment can be made to the lease correcting the termination date to read December 31, 2028. Staff recommends this be completed simultaneously with the other documents necessary for the assignment.

Assignee has not had a lease, permit, easement or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.

Rent re-opening is not scheduled until after the first ten years of the lease. There are no outstanding rental reopening issues.

No comments have been solicited or received from any agency or the community.

RECOMMENDATION:

That the Board consent to the Assignment of General Lease No. SP-0122, from Kelly Carswell-Haneberg and David Carswell, Assignors, to Marau Beck and Hobey Beck, Assignees, subject to the terms above which are hereby incorporated by reference and further subject to the following:

- a. That the lease be amended to correct the termination date to read December 31, 2028;
- b. The standard terms and conditions of the most current consent and/or amendment to lease forms, as may be amended from time to time;
- c. Review and approval by the Department of the Attorney General; and,
- d. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

Being a portion of Kokee Park  
(Governor's Executive Order 1509)

Beginning at a pipe at the northwest corner of this lot, the southwest corner of Lot 74 of Kokee Camp Site Lots, the coordinates of said point of beginning referred to Government Survey Triangulation Station "KOKEE" being 761.86 feet North and 124.40 feet West, as shown on H.S.S. Plat 3096, thence running by azimuths measured clockwise from True South:-

- 1. 276° 10' 145.57 feet along Lot 74 of Kokee Camp Site Lots to a pipe;
- 2. 42° 59' 229.39 feet along the remainder of Kokee Park (Governor's Executive Order 1509) to a pipe;
- 3. 122° 03' 30" 137.58 feet along the remainder of Kokee Park (Governor's Executive Order 1509) to a pipe;
- 4. 229° 16' 169.25 feet along the remainder of Kokee Park (Governor's Executive Order 1509) to the point of beginning and containing an AREA OF 0.56 ACRE.
