CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 3201, dated June 8, 1983, setting aside 3,152.177 acres designated as Honolulu International Airport under the control and management of the State of Hawaii, Department of Transportation, Airports Division (DOTA) for Airport Purposes.

CHARACTER OF USE:

MorphoTrust, as a contractor for the United States Transportation Security Administration (TSA), will use the space to operate and maintain a TSA Pre-check enrollment and processing center to allow for greater accessibility for the traveling public to sign up for the Pre-check program at Honolulu International Airport.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

Pursuant to Section 11-200-8(a), Environmental Impact Statement Rules of the Department of Health, State of Hawaii, this disposition is exempt from requirements regarding preparation of an environmental assessment, negative declaration, or environmental impact statement as required by Chapter 343, Hawaii Revised Statutes, as amended, relating to Environmental Impact Statements, because the proposed action falls within Exemption Class #1, Comprehensive Exemption List for the State of Hawaii, Department of Transportation, dated November 15, 2000, as approved by the

Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

REMARKS:

MorphoTrust plans to lease the terminal space on a month-to-month revocable permit for the construction, maintenance and operation of a TSA Pre-check satellite office for interested passengers to apply and process their “Pre-checked” status with the TSA. Currently, the terminal floor area is being used as a seating alcove in Lobby 3 in the Inter-island terminal. A small “office” will be erected to allow for confidential processing of passengers and a small waiting area will be used for passengers waiting for “Pre-check” status processing time.

RECOMMENDATION:


That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to MorphoTrust, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.



