Cancellation of Revocable Permit No. S-3842 and Issuance of Revocable Permit to Kapaa Ki-Aikido Club Inc. for Clubhouse Purposes, Wailua, Kawaihau (Puna), Kauai, Tax Map Key:(4) 4-1-009:018.

Kapaa Ki-Aikido Club Inc., a Hawaii non-profit organization.

LEGAL REFERENCE:

Sections 171-13 and -55, Hawaii Revised Statutes, as amended.

LOCATION:

Portion of Government (Crown) lands of Wailua situated at Wailua House Lots, 4th Series, Kawaihau (Puna), Kauai, identified by Tax Map Key: (4) 4-1-009:018, as shown on the attached map labeled Exhibit A.

0.358 acres, more or less.

Encumbered by Revocable Permit No. S-3842, Wailua Young Peoples Club, Permittee, for Clubhouse purposes. The Revocable Permit is on a month-to-month basis.

CHARACTER OF USE:

Clubhouse purposes.

COMMENCEMENT DATE:

The first day of the month to be determined by the Chairperson.

MONTHLY RENTAL:

\$480.00 per annum (Minimum Rent Policy for New Dispositions, May 13, 2005)

COLLATERAL SECURITY DEPOSIT:

Twice the monthly rental.

In accordance with the "Exemption List for the State of Hawaii, Department of Land and Natural Resources, as Reviewed and Concurred Upon by the Environmental Council (Docket 91-EX-2, December 4, 1991), the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No.1, "Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing [HAR § 11-200-8(a)(1)]." Exemption Class No. 4, which states, "Minor alterations in the conditions of land, water or vegetation [HAR § 11-200-8(a)(4)]".

REMARKS:

Wailua Young People's Club was formed back in the 1950's as an eleemosynary organization whose primary function was to serve the community. Members came from the surrounding area. The Wailua Young People's Club no longer exists.

The last inspection was done on July 11, 2014. The premises and building maintained and are in good condition. See attached photos.

The Kapaa Ki-Aikido Club, Inc. has been managing the site, paying the rent and insurance. They are a non-profit organization and listed with the County of Kauai as a community service organization and associated with the Hawaii Ki Federation. They collect dues from membership to pay for rent, insurance, utilities, etc. Instructors are volunteers and draw no salary.

The Hawaii Ki Federation. is a domestic 501(c)(3) nonprofit corporation. The Kapaa Ki-Aikido Club is in good standing with the Hawaii Ki Federation. See Exhibit C.

The Land Board is authorized to lease State lands to qualifying eleemosynary (charitable) organizations at nominal rent.

When considering rent amount for eleemosynary organizations, the Land Board may therefore set the rent by direct negotiation at an amount below fair market rental (i.e., nominal rent).

On May 13, 2005, the Land Board established a Minimum Rent Policy that stated, among other things, that the minimum rent to a charitable organization be no less than \$480 per year. In order to have a standard nominal rent for qualifying non-profit tenants, staff generally recommends rent be set at \$480 per year.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.



RECOMMENDATION: That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.

2. Authorize the cancellation of Revocable Permit No. S-3842.
3. Authorize the issuance of a revocable permit to Kapaa Ki-Aikido Club, Inc. covering the subject area for clubhouse purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current (non-profit) revocable permit form, as may be amended from time to time;
 - b. Review and approval by the Department of the Attorney General; and
 - c. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.




