REMARKS:

The Department of Transportation (DOT) has no objections to ACS's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to Public Purposes and Permits, respectively and therefore, the DOT proposes to issue a month-to-month revocable permit to ACS, Bldg/Room Nos. 233-105 and 233-106 for its air cargo operations at OGG.

RECOMMENDATION:



