REMARKS:

Under State Contract RFP: BS1202-43, Contract No. 60983, Maintenance of Passenger Loading Bridges and Baggage Handling Equipment-Statewide, 10.18- Provisions for Field Office/Storage Space allow for the winning Contractor to use space at respective airports at no charge, provided there is space available.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to Oxford Electronics, Inc. dba Oxford Airport Technical Services, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
