REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO SUBMIT A PROJECT-FUNDED STAFF SERVICES BUDGET REPORT FISCAL YEAR 2012-2013

This report is prepared pursuant to Section 42 of Act 164, Session Laws of Hawaii 2011, which reads:

Provided that of the general obligation bond fund appropriation for land and natural resources – natural physical environment (LNR 906), the sum of \$2,540,000 or so much thereof as may be necessary for fiscal year 2011-2012 and the same sum or so much thereof as may be necessary for fiscal year 2012-2013 shall be used for department of land and natural resources capital improvement program staff costs, statewide; provided further that the department of land and natural resources shall prepare a project-funded staff services budget report detailing each permanent position by number, position title, and compensation (including fringe benefits), in accordance with section 92F-12(a)(14), Hawaii Revised Statutes; provided further that the report shall include the details for non-permanent capital improvement program related positions; and provided further that the department of land and natural resources shall submit the budget report to the legislature no later than twenty days prior to the convening of the 2012 and 2013 regular sessions.

The Department of Land and Natural Resources (DLNR) is authorized 27.5 permanent Capital Improvements Program (CIP) positions for Fiscal Year 2012-2013. The following is DLNR's CIP staff cost budget report for Fiscal Year 2012-2013.
