SUBJECT: RFP 11-05, Proposals to Furnish Pharmacy Benefit Management Services

In consultation with EUTF's counsel, we have determined that RFP 11-05 contained a process flaw due to an ambiguity in the submission process instructions. Therefore, **RFP 11-05 is cancelled**. The EUTF will issue a new RFP 11-06 to furnish pharmacy benefit management services -- please refer to the appropriate State of Hawaii State Procurement Office website. The new RFP will also be posted on EUTF's website.

If you have previously submitted a full Proposal including BOTH hard copies and an electronic submission under RFP 11-05 to the EUTF office listed below and to Segal and wish to resubmit that Proposal as a response to this request, RFP 11-06, a signed letter authorizing the EUTF to accept the material submitted under that RFP 11-05 to be considered as your complete response to this RFP 11-06 may be submitted in lieu of a complete response to this RFP. Please note the letter should be addressed to Sandra Yahiro, Procurement Officer and must be received at the EUTF Office by May 27 at 4 PM HST.

If the letter is not received in the EUTF office by May 27, 2011, 4:00 p.m. (HST), or if a new proposal adhering to all instructions in RFP 11-06 is not received in the EUTF office by May 27, 2011, 4:00 (HST), the EUTF will assume that you did not wish to resubmit a proposal.

IF YOU HAVE FAILED TO SUBMIT EITHER THE HARD COPIES REQUESTED OR THE ELECTRONIC COPY TO RFP 11-05, the missing hard copies or electronic copy MUST BE SUBMITTED with your letter by May 27 to the addresses in RFP 11-06.

If you wish to modify in any way the proposal submitted under RFP 11-05 for this RFP 11-06, you must submit an entirely new proposal under this request including the Signed Master and Two Signed copies according to the instructions in this RFP and also submit a new electronic proposal on the E-RFP web site.
