ORDER GRANTING MOTION TO DELETE AND SUBSTITUTE  
CONDITIONS OF THE DECISION AND ORDER

Petitioner, Hamakua Sugar Company, Inc., successor in interest to Honokaa Sugar Company, filed its Motion To Delete Conditions on October 3, 1989, to delete Condition Numbers 1, 2 and 4 of the Land Use Commission's Decision and Order of June 3, 1976, and Condition Number 3 of the Land Use Commission's Decision and Order of July 5, 1978 and orally moved at the Commission's June 28, 1990 meeting, to substitute the four deleted conditions with a new condition relating to affordable housing, pursuant to Section 15-15-70, Hawaii Land Use Commission Rules. The Land Use Commission, having duly considered Petitioner's motion and proposed new condition at its meeting of June 28, 1990, at Honolulu, Hawaii, and the Office of State Planning and the County of Hawaii Planning Department being in support of the motion and imposition of the new housing condition, and good cause appearing therefrom,

HEREBY ORDERS that Petitioner's motion, as amended, be granted. Accordingly, Conditions 1, 2, 3 and 4 of the

Commission's Decision and Order of June 3, 1976 are deleted and the following new condition of approval is hereby imposed upon the subject property:

1. Hamakua Sugar Company, Inc., within two (2) years of the release of the existing mortgage and forbearance agreements which cover the real property owned by Hamakua Sugar Company, Inc. located in the County and State of Hawaii, shall provide housing opportunities to the current employees and pensioners of Hamakua Sugar Company, Inc. by offering a minimum of 100 lots for sale or rent, with at least thirty percent (30%) of the lots or units at prices which families with an income range of up to one hundred twenty percent (120%) of the County of Hawaii's median income can afford, and seventy percent (70%) of the lots or units at prices which families with an income range of one hundred twenty to one hundred forty percent (120-140%) of the County of Hawaii's median income can afford, at an off-site location or locations under such terms as may be mutually agreeable between Hamakua Sugar Company, Inc., the Housing Finance and Development Corporation of the State of Hawaii and the County of Hawaii.


