AND TO CORRECT ACREAGE OF PETITION



McClean Trust, filed a motion on January 23, 1991, to change Petitioner's name to McClean Honokohau Properties, a Hawaii Limited Partnership, to accurately reflect Petitioner's legal standing as represented in its Exhibit 13-A, and to correct the acreage description of the Property being considered for redistricting from the Conservation to the Urban District, from 74.605 acres to 72.40 acres and from the Agricultural to the Urban District from 14.922 acres to 17.127 acres, pursuant to Sections 15-15-43 and 15-15-70, Hawaii Land Use Commission Rules.

The Land Use Commission, having duly considered
Petitioner's motion at its meeting on January 24, 1991, at
Kailua-Kona, Hawaii, and there being no objections from the
other parties to the proceedings,
