#### CALL TO ORDER

Chair Wong called the meeting to order at 9:30 a.m.

#### APPROVAL OF MINUTES

Chair Wong updated the record, and described the procedures for the hearing. There were no questions or comments on the procedures.

Chair Wong had Mr. Orodenker explain that the decision to approve the docket had already been made and that this was the administrative adoption of the form of the order to complete the proceedings on the matter; and described the IAL designation process.

#### **HEARING AND ACTION**

#### A17-803 KEALIA PROPERTIES, LLC- (Kaua'i)

To Consider Petitioner's Motion to Designate the Land Use Commission as Approving Authority for Environmental Statement Under HRS Chapter 343 and For Authority to Prepare Environmental Impact Statement Preparation Notice.

Chair Wong called for the Parties identify themselves.

Chair Wong updated the record, and described the procedures for the hearing. Chair Wong asked if Petitioner had been made aware of and was agreeable to the LUC's hearing expenses reimbursement policy. Mr. Tabata acknowledged that Petitioner was

aware of and would comply with the reimbursement policy. There were no questions or comments on the procedures

Chair Wong called for Public Witnesses and swore each witness in before hearing their testimony.

#### PUBLIC WITNESSES:

1. Timothy Reis

Mr. Reis requested clarification on the process involved with the proposed project and the environmental impact statement. Mr. Tabata described how the environmental impact statement (EIS) information was being gathered and took Mr. Reis' contact information to provide follow up information.

Commissioner Scheuer commented that the Commission's action was limited in scope to agree to be the accepting authority for the EIS at this meeting.

There were no other witnesses.

#### **PRESENTATION**

Petitioner

Mr. Tabata made his presentation to the Commission and argued why the LUC should be the accepting authority for the Environmental Impact Statement (EIS) and why an EIS was warranted; and described the reasons why his motion should be granted.

Commissioner Chang requested clarification on whether the EIS would include an Archaeological Inventory Survey and Cultural Impact Assessment. Mr. Tabata responded that the EIS would address the issues that the State Historic Preservation Division (SHPD) would be concerned with.

#### **AGENCY COMMENTS**

The County stated that it had no objection to the motion.

Ms. Apuna stated that OP had no objection to the motion.

#### **DECISION MAKING**

Commissioner Estes moved to approve the Petition. Commissioner Mahi seconded the motion.

Commissioner Ohigashi offered a friendly amendment to include that the motion would:

- 1) Identify the Commission as the "accepting authority," to review and accept the applicant's proposed actions pursuant to Chapter 343, HRS; and,
- 2) Direct the Petitioner to prepare an EISPN because the Commission determined, based on its judgment and experience, that under Chapter 343-5(e), HRS, the proposed action may have significant effects requiring the preparation of a full environmental impact statement.
- 3) Authorize the Executive Officer to notify and submit a record of the Commission s decision to Kealia and OEQC by the November 15, 2017, deadline. It was further recommended that the motion specify that the Commission authorizes the Chair to sign any Order on this matter on behalf of the Commission.

Commissioners Estes and Mahi had no objection to the friendly amendment. Commissioner Scheuer requested clarification that the specifics of the motion and its friendly amendment just addressed the LUC's role as accepting authority and not the approval of the EIS. Chair Wong acknowledged that the motion was limited to the LUC's being the accepting authority.

There was no further discussion.

Chair Wong had Mr. Orodenker poll the Commission.

The Commission unanimously voted in favor of the motion with the friendly amendment. (7-0-2 excused).

Chair Wong declared a recess at 9:59 a.m. and reconvened the meeting at 10:10 a.m. and moved on to the next agenda item.

#### **PRESENTATION**

Petitioner

Mr. Tabata made his presentation to the Commission and argued why the Special Permit should be granted.

Commissioners Cabral, Ohigashi, Chang and Scheuer requested clarification on Mr. Tabata's presentation.

### County

Ms. Higuchi stated that County was in support of the permit and recommended approval with conditions.

There were no questions for Ms. Higuchi.

OP

Ms. Apuna stated that OP had reviewed the permit and recommended the deletion of Conditions 22 and 23; and that the Commission approve the permit with those changes.

#### **DECISION MAKING**

Chair Wong entertained a motion.

Commissioner Cabral moved to approve the Special Permit application for AES Lāwa'i Solar, LLC subject to the conditions as recommended by the Kaua'i Planning Commission in their Findings of Fact, Conclusions of Law, and Decision and Order dated September 26, 2017; with the following changes:

- deletion of conditions 22 and 23 as requested by OP;
- amendment to Condition 7 to require LUC approval of any time extensions to the Special Permit;
- amendment to Condition 18 to clarify that any relief would be granted by the County Planning Commission;
- amendment to Condition 14 to require Petitioner's submittal of a SHPDapproved Archaeological Monitoring Plan before work begins; and,
- request staff to make any changes for renumbering, grammar, spelling, Hawaiian diacriticals, and clarity that is necessary

#### Discussion

Chair Wong stated that he would be voting in favor of the motion and described his support of alternative energy sources.

Commissioner Scheuer stated that he also was voting in favor of the motion and expressed his appreciation to all concerned with the special permit application effort.

Chair Wong had Mr. Orodenker poll the Commission.

The Commission unanimously voted in favor of the motion. (7-0-2 excused).

Chair Wong declared at recess at 10:59 a.m. and reconvened the meeting at 11:01 a.m.

Discussion ensued regarding the remaining items on the agenda.

Commissioner Ohigashi moved to amend the agenda and to have the Executive Session that was scheduled for November 9, 2017 rescheduled to start at 12:30 p.m. on November 8, 2017. Commissioner Mahi seconded the motion. By unanimous voice vote (7-0-2 excused), the Commission voted to amend the agenda and begin the Executive Session as proposed.

The Commission went into recess at 11:03 a.m. and reconvened at 12:30 p.m.

Commissioner Chang moved to enter into Executive Session. Commissioner Scheuer seconded the motion. By unanimous voice vote (7-0-2 excused), the Commission voted to enter into Executive Session.
