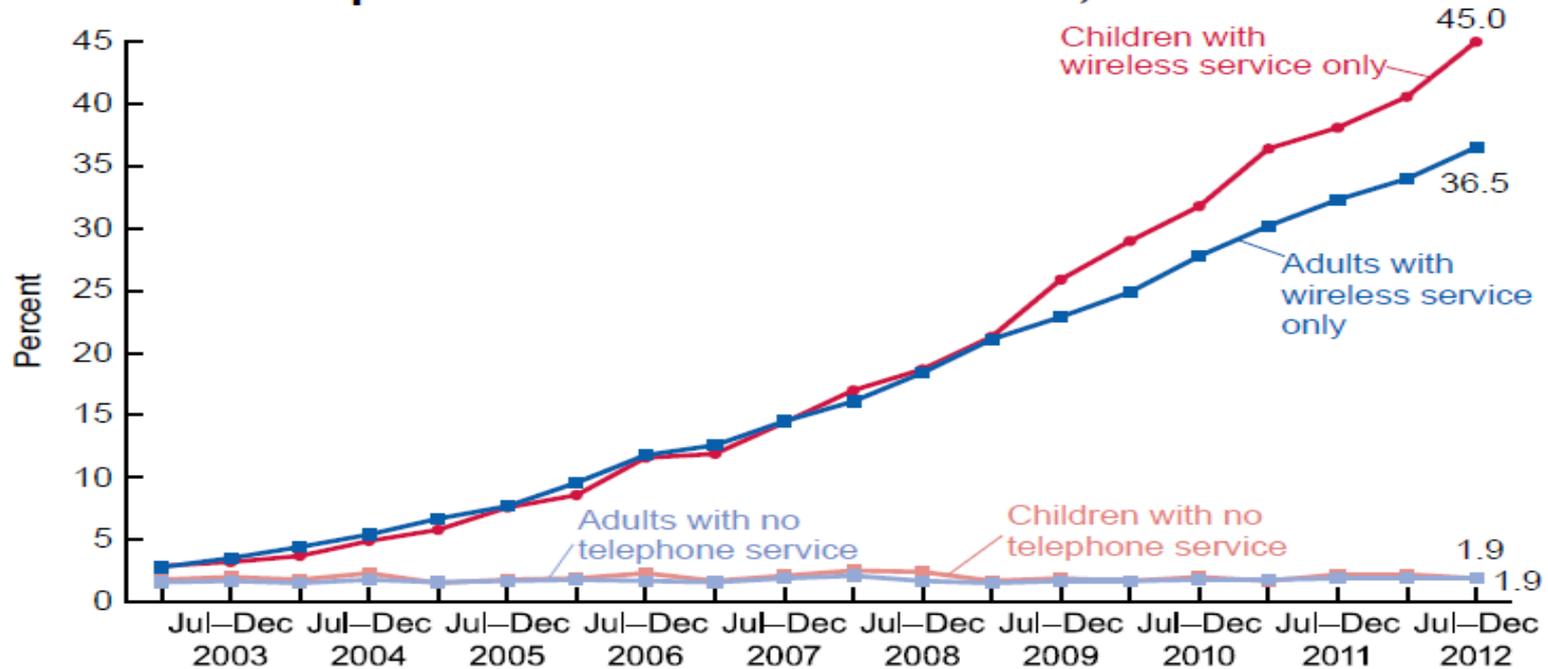

Percentages of adults and children living in households with only wireless telephone service or no telephone service: United States, 2003–2012



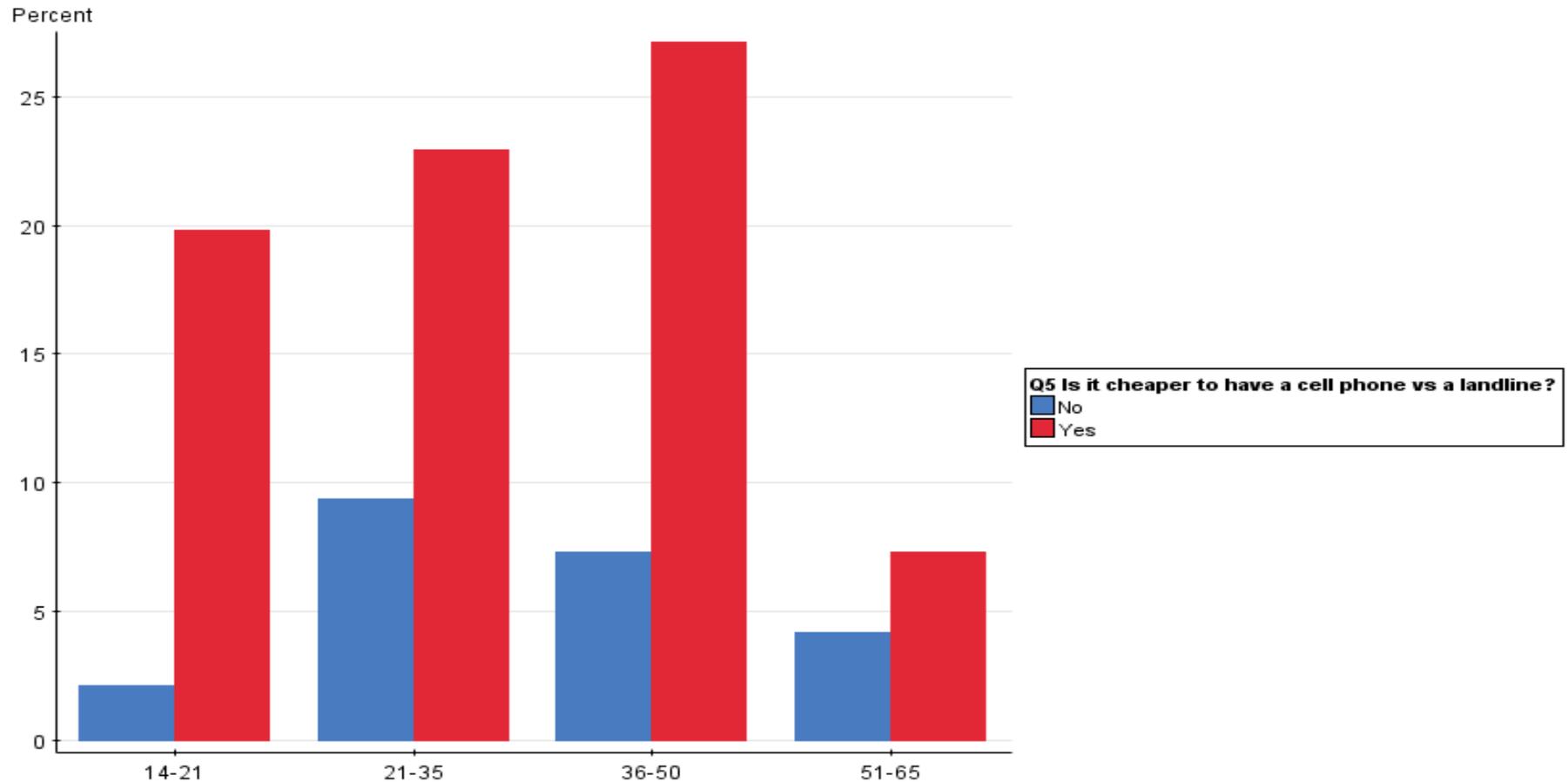

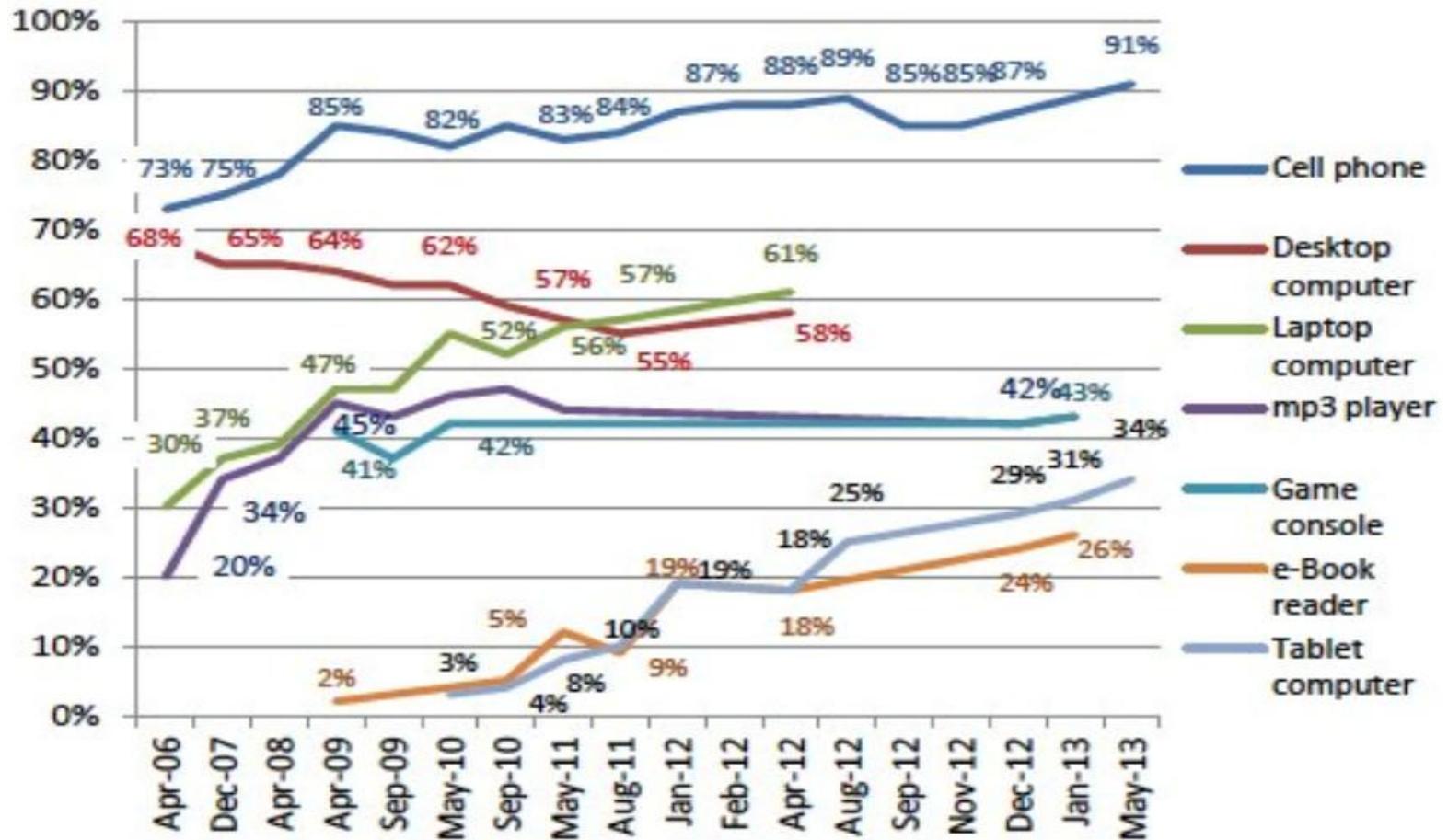

 - Taxpayers can manage their tax account online
 - Focus is on keeping taxpayer interaction as convenient as possible
- Montana Department of Revenue wanted to embark on mission to embrace mobile-optimized payment services

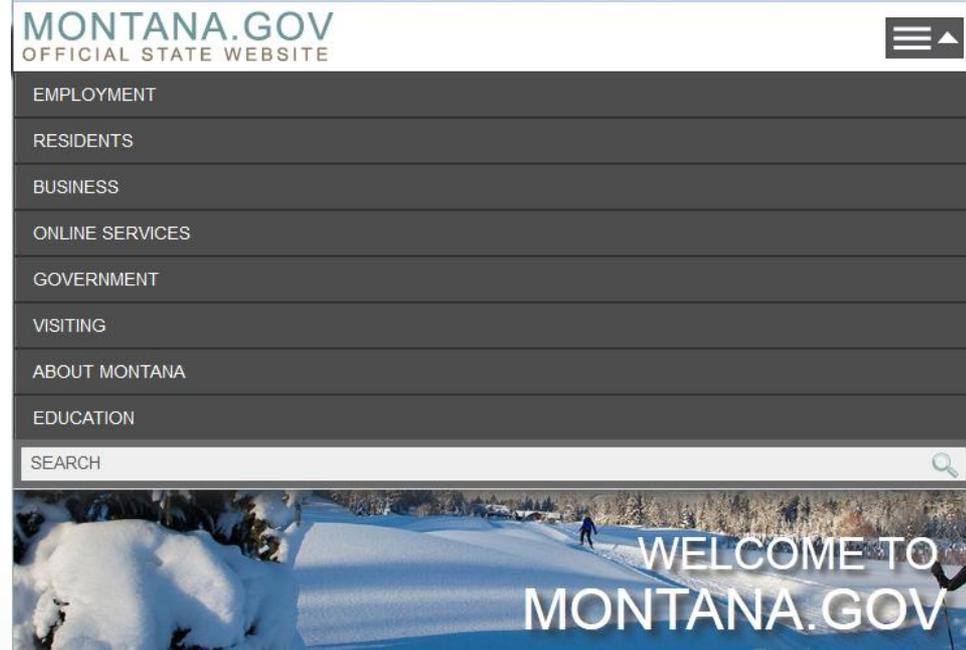

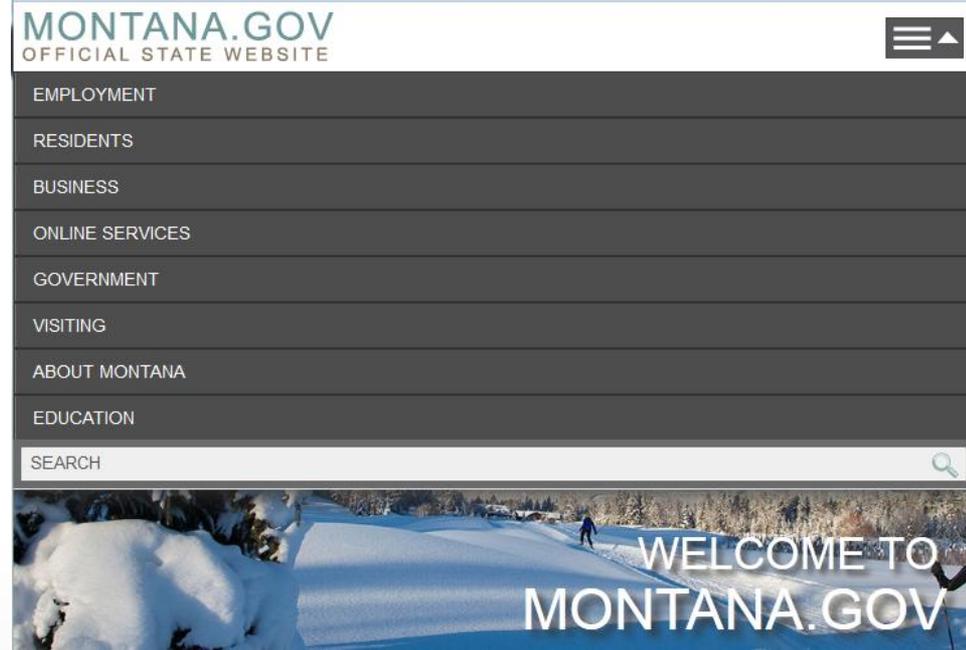
Responsive Designed Websites Increase

MOBILE DESIGN CONSIDERATIONS

Responsive vs. Native

Native Application

“One way to ensure that applications show optimum performance on a given device is to develop the application (app) natively on that device. This means that at a very low level, the code is written specifically for the processor in a particular device. When an app needs to run on multiple operating systems, however, there is little -- if any -- code that can be reused from the initial development. The application must essentially be rewritten for each specific device.”

Development Contractor Security Compliance

- PCI (Payment Card Industry) Compliant, with yearly re-certifications
- Cyber trust-certified enterprise, with yearly re-certifications
- SOX (Sarbanes-Oxley) compliant, with quarterly re-certifications
(Vendor Requirement)

Security Practices

- HTTPS only across the entire enterprise
- The entire user experience is encrypted used 256-bit SSL (Secure Sockets Layer)
- SSL certificate strengths and weaknesses are reviewed quarterly
- Active network and web application firewalls; attacks are stopped in real-time and aggressive traffic is terminated

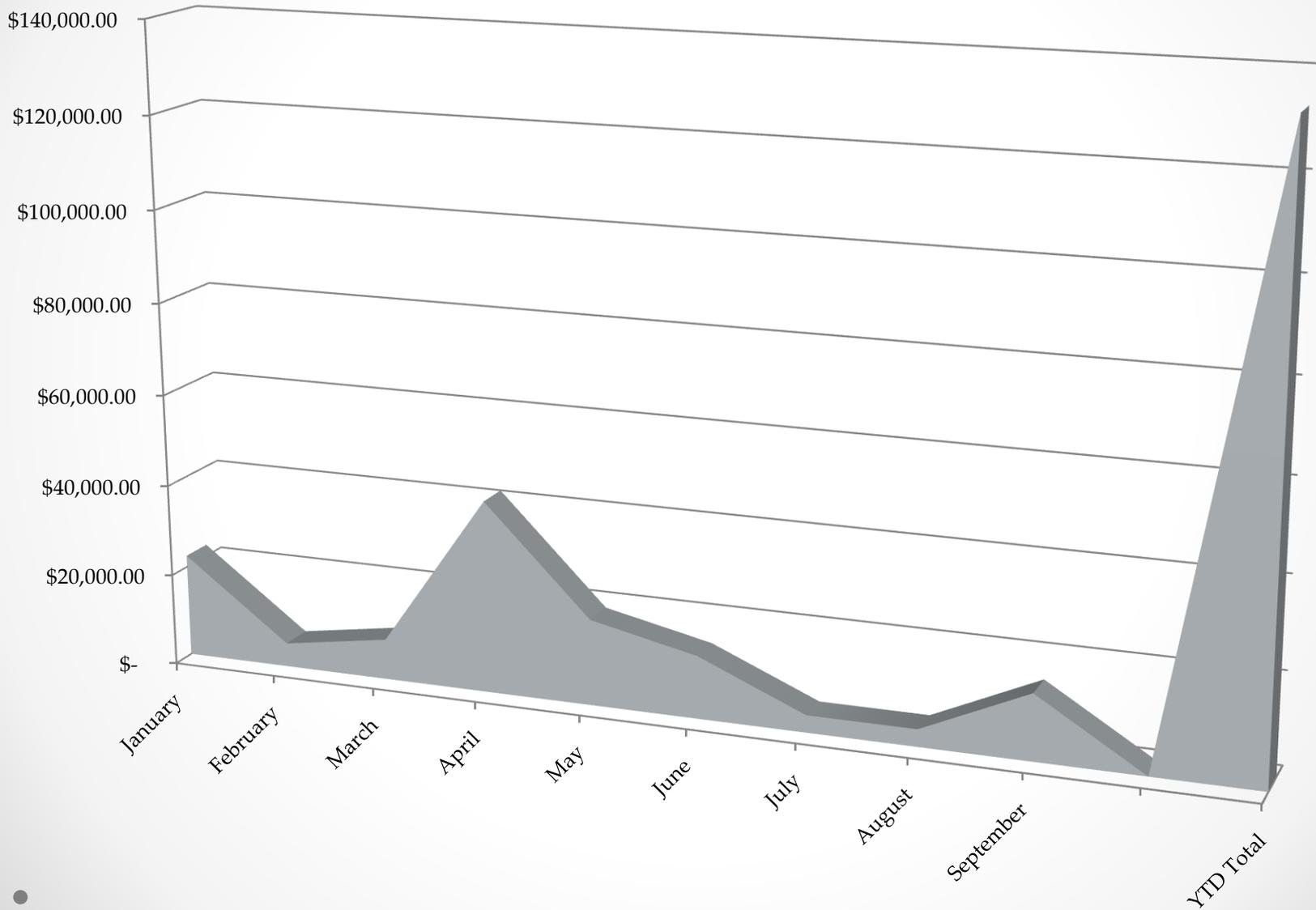

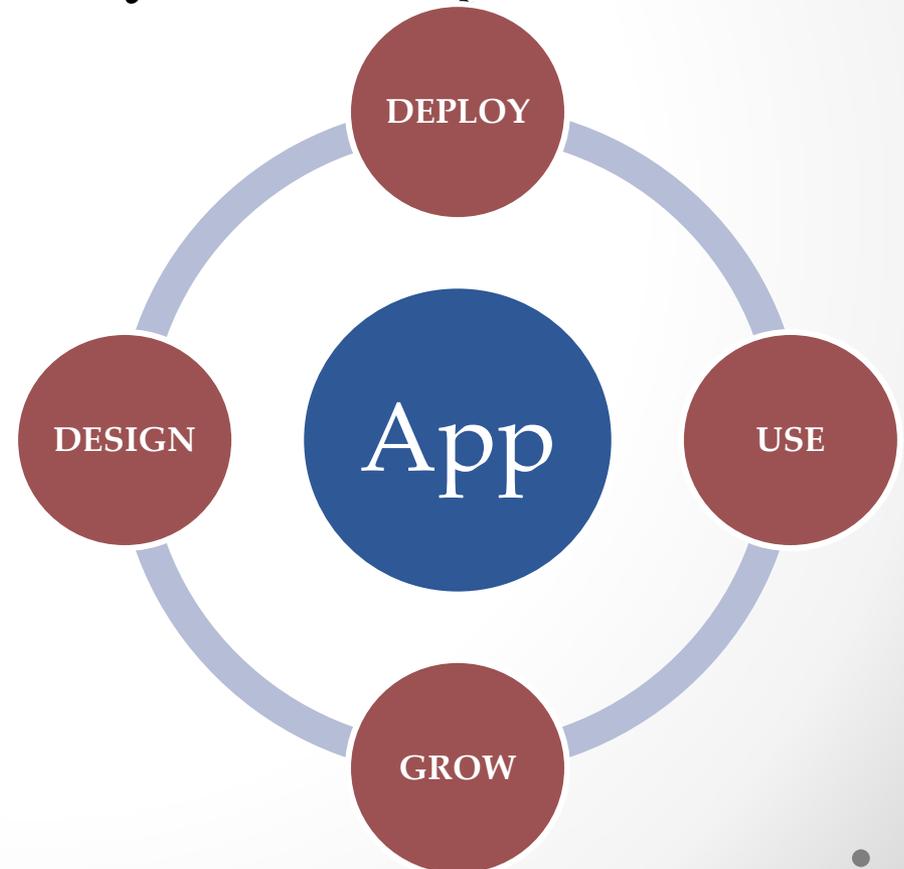

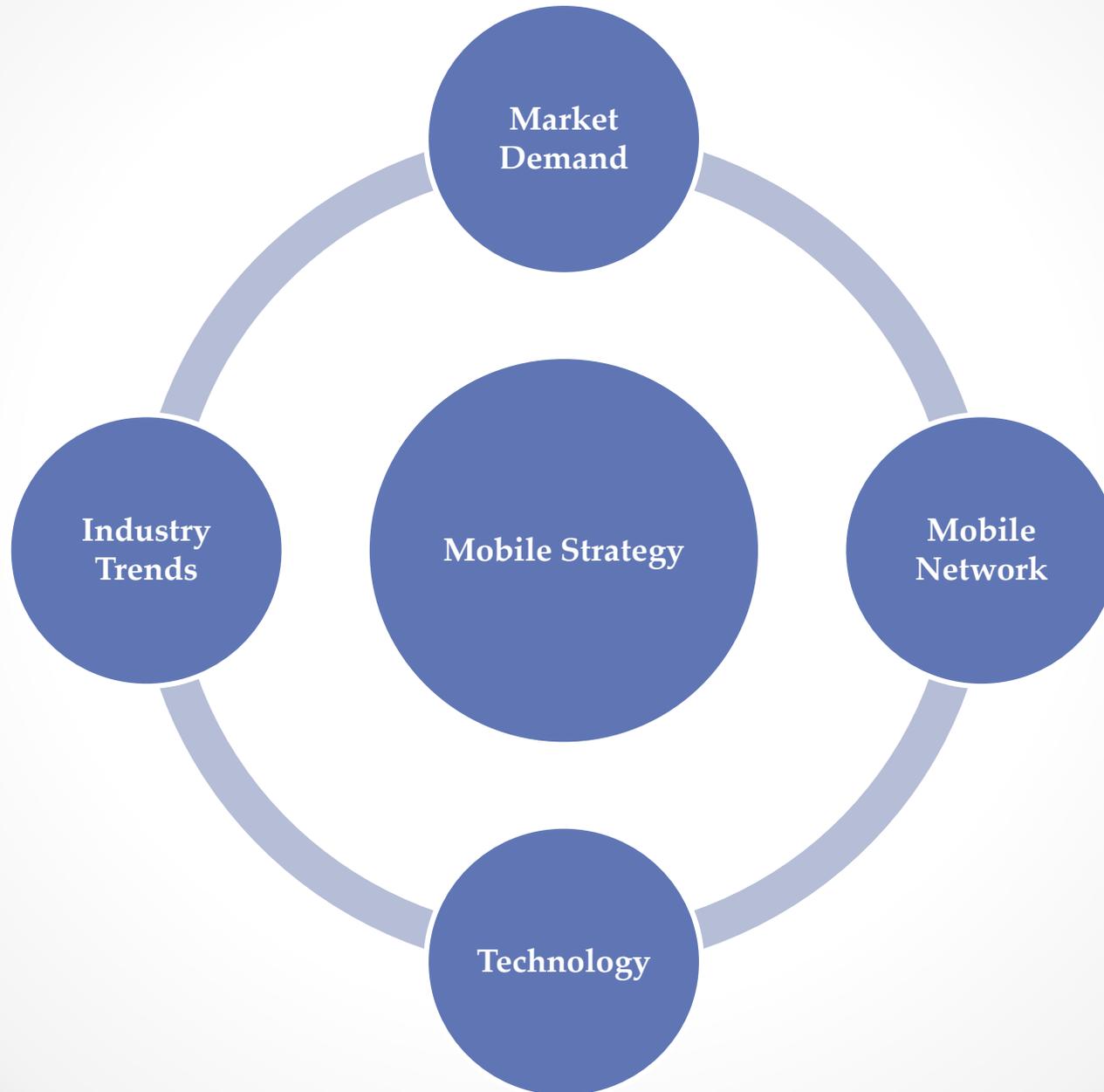

MARKET DEMAND

Consumers Increase Mobile App Usage

- Consumer time spent with Apple iOS and Android retailer apps jumped 525% year-over-year in December 2012. (e.g., ShopSavvy). —Flurry

Consumer Payment App Usage Increases

- On Cyber Monday 2012, PayPal's mobile payment volume increased 190% globally year-over-year.
- Over seven million customers now use Starbucks' mobile payment app, translating into 2.1 million mobile payment transactions each week .

MOBILE NETWORK GROWTH

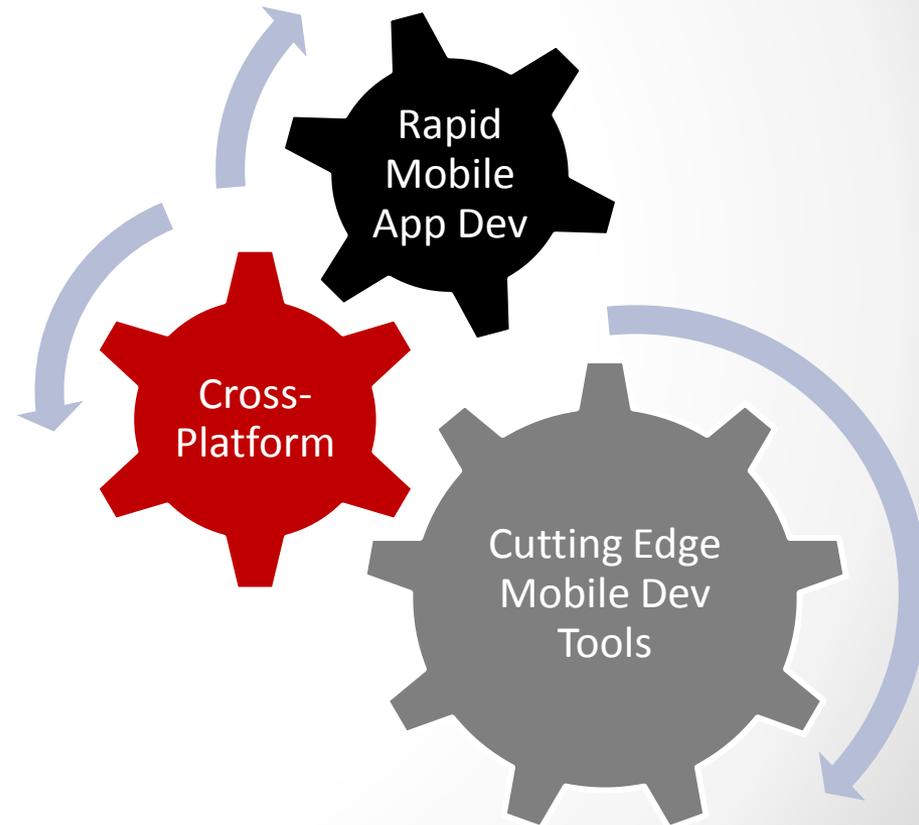
- Smartphone usage grew 81 percent in 2012
- Smartphones, laptops, and tablets will drive 93 percent of global mobile data traffic by 2017
- Mobile network connection speeds more than doubled in 2012
- Last year's mobile data traffic was nearly twelve times the size of the entire global Internet in 2000
- Mobile Data Explosion - 13 fold increase in mobile data traffic by 2017
- Mobile network connection speeds will increase 7-fold by 2017
