**DEPARTMENT OF TAXATION ANNOUNCEMENT NO. 2013-05**

RE: Revised Kauai County Fuel Tax Rate, Effective July 1, 2013

Kauai County Resolution No. 2013-47 Draft 3 increases the county of Kauai fuel tax rates.

Effective July 1, 2013, the county of Kauai fuel tax rate for diesel, gasoline, and liquid fuel sold or used by a distributor is increased from thirteen (13) cents per gallon to fifteen (15) cents per gallon. Effective July 1, 2013, the county of Kauai fuel tax rate for compressed natural gas (CNG), ethanol, liquefied natural gas (LNG), liquid petroleum gas (LPG), and methanol sold or used by a distributor are also increased. There is no change in the rate for biodiesel. See the attached "Schedule of Fuel Tax Rates (Effective July 1, 2013)" for all counties. The tax increases apply to fuel sold or used by distributors on or after July 1, 2013 (including stock that was purchased by distributors before July 1, 2013, but sold or used by distributors on or after July 1, 2013).

Effective July 1, 2014, the county of Kauai fuel tax rate for diesel, gasoline, and liquid fuel sold or used by a distributor is increased from fifteen (15) cents per gallon to seventeen (17) cents per gallon. Effective July 1, 2014, the county of Kauai fuel tax rates for compressed natural gas (CNG), ethanol, liquefied natural gas (LNG), liquid petroleum gas (LPG), and methanol sold or used by a distributor are also increased. There is no change in the rate for biodiesel. The tax increases apply to fuel sold or used by distributors on or after July 1, 2014 (including stock that was purchased by distributors before July 1, 2014, but sold or used by distributors on or after July 1, 2014). Subsequent increases will be addressed in subsequent announcements before each increase in tax becomes effective.

The applicable fuel tax forms are being revised and will be available shortly at the district offices of the Department of Taxation.
