**DEPARTMENT OF TAXATION 2006 SUMMER WORKSHOPS  
ON OAHU AND NEIGHBOR ISLANDS**

HONOLULU—The Department of Taxation's Summer Workshop 2006 series will begin on Tuesday, July 25, 2006, with its first session on Kauai. The remaining workshops on Oahu and Maui and in Kona and Hilo will be held within the following weeks (see schedule on the following page).

All workshops begin at 8:30 A.M. and end at 12:30 P.M. Presentation topics include the Tax Legislation Updates; meet the New IRS and State Taxpayer Advocates; County Surcharge Information; Compliance Initiatives; and Tax Services Changes and Filing Tips.

The cost for the workshop is \$60 for persons registering at least two weeks prior to the workshop date. An additional \$5 fee is charged for late registrations. The cost includes continental breakfast, workshop packet, and four (4) hours of Continuing Professional Education (CPE) credit. The workshop packet may be separately ordered for \$15 a set.
