# Department of Taxation Announces 2014 Summer Tax Workshop Schedule

HONOLULU — The Department of Taxation's 2014 Summer Tax Workshops on Hawai'i, Maui, Kaua'i, and O'ahu, will kick-off in Hilo on Wednesday, August 6, 2014.

This year's workshop topics include a 2014 legislative and administrative update, and an overview of the Hawaii Real Property Tax Act.

"We're pleased to present our annual Summer Workshops for the state's tax professionals," said Director of Taxation Fred Pablo. "These workshops provide us a chance to update and educate our tax community on issues, as well as provide the community an opportunity to share their ideas and suggestions."

All workshops run from 8:30 a.m. to 11:30 p.m., with registration starting at 8:00 a.m. The fee is \$80 for persons who submit their registration and payment by the deadline. Late registrations are \$100. Walk-in registrations will be accepted at the door on a space-available basis. The fee includes a continental breakfast, workshop materials, and three (3) hours of Hawai'i Board of Public Accountancy Continuing Professional Education credit.
