Effective July 1, 2010, the environmental response tax (ERT) rate increased from \$0.05 to \$1.05 per barrel.

Effective July 1, 2015, the ERT includes a tax on fossil fuels (not including petroleum products) at \$0.19 per million British thermal units.

*Fuel tax collections were \$16,731,440.26 in October. Of the collections, \$180,401.34 could not be distributed because the corresponding tax returns were not yet available. The \$16,729.25 undistributed fuel tax from previous months is included in the October 2017 report.
